AGREEMENT TO TERMINATE

SIDEWALK PRIVILEGE AGREEMENT

This Agreement made by and between the City of Manitowoc, Wisconsin, a municipal

corporation, hereinafter referred to as "City" and Automotive Manitowoc, LLC, hereinafter referred

to as "Owner".

The parties hereto agree as follows:

1. Previous Grant. The City has previously granted to the previous Owner, Ramona Bouril,

deceased, the privilege to use the following described portion of the City right-of-way for the

purpose of erecting and maintaining an advertising sign, more specifically described as:

A parcel of land located in the Northwest Quarter of the Northwest Quarter (NW ¼, NW ¼) of

Section 36, Township 19 North, Range 23 East, City of Manitowoc, Manitowoc County,

Wisconsin, and being more particularly described as follows:

Commencing at the north quarter corner of said Section 36; thence south along the west line

of said northwest quarter section line, also being the centerline of South 35th Street, a

distance of 665.5 feet to the south line of Kadow's Addition No. 1 extended; thence S 87° 20'

E along said subdivision line, a distance of 1629.50 feet to the southwest corner of Block 11,

Kadow's Addition No. 1, and the true point of beginning; thence continuing S 87° 20' E, a distance of 41.37 feet, to a point 42.5 feet southeast of the centerline of Calumet Avenue;
