**FINDINGS OF FACT
CONCLUSIONS OF LAW
AND RECOMMENDATION
(Failure to Appear)**

The Licensing Permits and Inspections Committee of the Common Council having conducted a hearing on Monday, August 18, 2014, in the above matter, pursuant to Wisconsin Statutes §125.12, regarding the application of Jessica L. Ludwig ("the applicant") for renewal of her Operator's License; and

Bridget Brennan, Deputy Chief of Police, having appeared as the complainant and the applicant having failed to appear in response to the Notice of Intention Not to Renew License;

The Licensing Permits and Inspections Committee hereby make the following Findings of Fact, Conclusions of Law and Recommendation:

FINDINGS OF FACT

1. The applicant currently holds an Operator's License to dispense alcohol beverages.
2. The applicant owes the City of Manitowoc \$1,230.60 in unpaid forfeitures.
3. Pursuant to Wisconsin Statutes §125.12(2)(b)3, the Committee finds the allegations of the Notice of Intention Not to Renew the License are true.

CONCLUSIONS OF LAW


Based on the applicant's failure to pay forfeitures owed the City, she does not possess the qualifications to hold an Operator's License under Wisconsin Statutes §125.04(5)(a)1.

RECOMMENDATION

The Licensing Permits and Inspections Committee hereby recommend that the license application of Jessica L. Ludwig be denied.

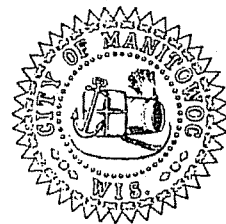
