I am inquiring about the addition of a few more "No Parking" signs on the south side of the road on Quay street in front of our large truck scale. In recent years, we have seen an increase of parking on the road just to the north of our dock loading area on Quay street. There were a number of instances last year where we had to send management across the road to the Wharf to track down the vehicle's owners to have the car moved. Staff at the Wharf have been absolutely accommodating in helping us find owners when we have issues. We would like to see if we could get some additional "No Parking" signs to eliminate the issue as much as possible.
