SCOPE OF WORK:

The City of Manitowoc is planning to revert N 8th St and N 10th St to two-way traffic. This will result in geometric changes for 4 intersections as outlined in Attachment B. (N 8th Street & Waldo Blvd, N 8th St & Cleveland Ave, N 10th St & Water St, and N 11th St & Menasha Ave)

Stantec will hire Corner Point to prepare a preliminary survey of the four intersections. Stantec will review potential site plan options and provide intersection design plans which will include the site, grading, striping, signage, utility, and traffic control plans as necessary for the improvements proposed for the four intersections. An estimate of probable construction costs with bid quantities will be prepared for each intersection, as well as specifications and special provisions. The signal design for the intersection of 8th and Waldo will be prepared by Traffic Analysis & Design (TADI). Stantec will incorporate the work completed by TADI into the intersection construction plans developed during this work. Stantec will provide limited construction administration and observation services by responding to Contractor Requests for Information (RFI's), review shop drawings, perform site visits (maximum 40), and respond to field construction issues.

Additionally, Stantec will work closely with the Client and Owner to meet schedule expectations and develop a mutual agreement of when the final deliverables will be completed
