Re: MPU Bank First New Account

Honorable Mayor and Members of Council:

Bank First is offering a money market account which pays interest at a rate of 10bps above the Local Government Investment Pool (LGIP) Fund Rate adjusted monthly. Information on the LGIP is attached. No fees are associated with this account. Currently MPU's short term investments are held with Baird and invested in one year treasury securities. This account is subject to fees of 15bps.

Below is a comparison of MPU's actual investment performance in the short term account of Baird to the LGIP average annual rates.
