Dear Mr. Koski:

By way of introduction, I am a member of The Progress Lakeshore Business Retention and Expansion Committee (BRE). I had a conversation this morning with Karen from your office and she requested that I send an email to you regarding this issue. I am part of the sub-committee working on improving the appearance of Downtown Manitowoc.

As our first project, we propose attracting tourists from the Badger Dock to South 8<sup>th</sup> Street, thru the corridor between the Manitowoc Public Library and the Farmer's Market site. A member of the sub-committee, Mr. Bernard Nelson, horticulturist, who recently moved to Manitowoc from Madison, WI where he was a college horticulture instructor and also was responsible for the grounds at the State Capital, submitted an opinion to meet this objective. He suggested using 22-24 inch flower pots grouped at the Badger entry/exit and four additional grouping along Quay Street. Cost



estimate for 16 resin/fiberglass colored pots with a three year life expectancy (Lowe's), dry materials and flowers (exotics and tropical) is \$1,700, with a potential 10% discount.

Karen stated that you would most likely discuss this proposal with the Manitowoc City Council at their next meeting, April 4<sup>th</sup>. For complete disclosure, two additional individuals serve on this sub-committee: Barry Nelson, Downtown Manitowoc Businessman; and, Jodi Schramm, Progress Lakeshore Business Assistance Specialist. Please contact me if I can be of further assistance.
