ORDINANCE

An Ordinance to annex certain territory from the Town of Newton to the City of Manitowoc as part of the 9th Aldermanic District and the 17th, 18th, 21st, 23rd, 24th, 25th, 26th and 28th Wards of the City.

WHEREAS, the petition to annex the territory described below has been filed with the City of Manitowoc; and

WHEREAS, the petition meets the requirements of Wisconsin Statute Section 66.0223; and

WHEREAS, the Manitowoc Common Council has determined that the City has reasonable need for the property and it is in the best interest of the petitioners, the residents and owners of property in the area to be annexed and the City of Manitowoc to annex the property to the City; and

NOW, THEREFORE, the Mayor and Common Council of the City of Manitowoc do ordain as follows:

SECTION 1. Territory Annexed. Pursuant to Wisconsin Statute Section 66.0223, the following described territory in the Town of Newton, Manitowoc County, Wisconsin is hereby annexed to the City of Manitowoc:

DESCRIPTION

A tract of land located in the NW ¼ of the NE ¼, in the SW ¼ of the NE ¼ and in the NE ¼ of the NW ¼ of Section 2, T. 18N., R. 23E., Town of Newton, Manitowoc County, Wisconsin described as follows:

Commencing at the North ¼ corner of said Section 2, the point of real beginning, thence N89°43'17"E (recorded as N88°26'27"E) along the section line 70.30 feet to the South ¼ corner of Section 35, T.19N., R.23E., thence N89°53'18"E (recorded as N88°26'27"E) along the section line 1005.13 feet to the west right of way of I-43, thence S30°28'55"E (recorded as S32°09'53"E) along said right of way 87.90 feet to a point on a 3629.72 foot radius right of way curve to the right, thence southeasterly along the arc of said curve 1067.77 feet (chord S10°34'57"E 1063.93 feet (recorded as S12°15'55"E)) to the east line of said NW ¼ of the NE ¼ and the SW ¼ of the SW ¼ of the NE ¼ also being the west right of way of I-43, thence S00°57'04"W (recorded as S00°43'51"E) 708.21 feet, thence S87°43'33"W 1332.78 feet to the ¼ section line, thence N00°51'15"E along said ¼ section line 633.90 feet to the south line of said NE ¼ of the NW ¼, thence S88°30'34"W along said south line 1322.16 feet to the west line of said NE ¼ of the NW ¼, thence N00°36'42"E along said west line 1278.40 feet to said section line, thence N89°43'17"E along said section line 1326.72 feet to the point of real beginning.

WHEREAS Section 5.15 of the Wisconsin State Statutes (as amended by Chapter 4 of the Laws of 1981) requires cities to create Wards, and

WHEREAS the Manitowoc Common Council did annex territory (Hecker #3 Annexation Area), and

WHEREAS an Attorney General's opinion has indicated that districts set by reapportionment are not changed by annexation in regards to voting,

NOW, THEREFORE, be it resolved that the City of Manitowoc creates Ward Number 32, population zero (0), for the Hecker #3 Annexation Area and provides the following boundary description:

DESCRIPTION

A tract of land located in the NW ¼ of the NE ¼, in the SW ¼ of the NE ¼ and in the NE ¼ of the NW ¼ of Section 2, T. 18N., R. 23E., Town of Newton, Manitowoc County, Wisconsin described as follows:

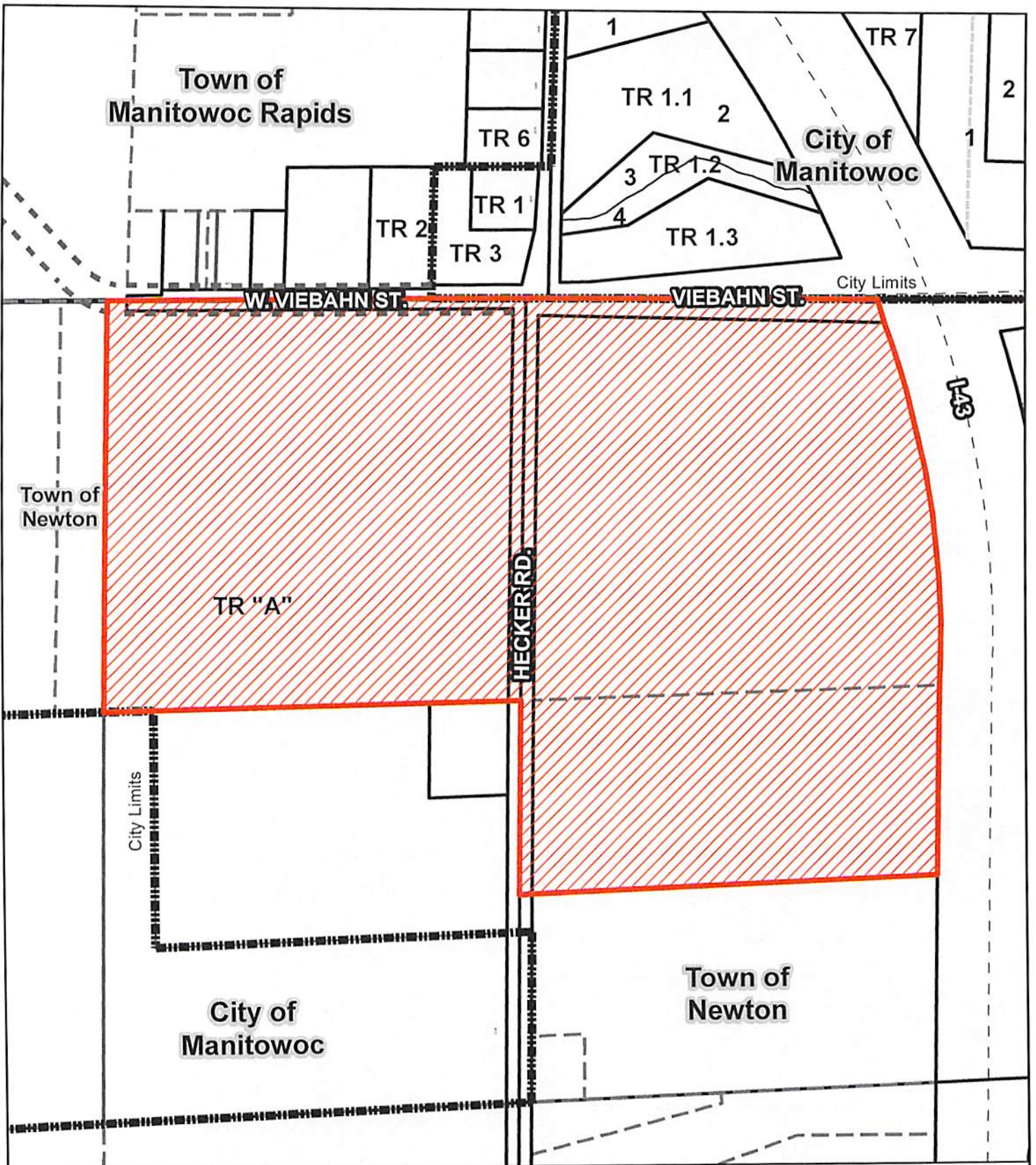
