There is a bad spot about 80 – 100 ft. long and it is probably right behind his house. See the photos. The rest of the alley was not too bad.

In 2014, this alley was rated with a PASER condition rating of CR-6, which is fair condition. I would say it is still at a 5 overall.

Unless this is something that the DPI would go and dig out and repave the section this year or next, I would guess that this would be several years out (3-6 yrs.) yet before it would be on the capital improvement plan for reconstruction. There are several other alleys that are in worse shape than this one.
