ORDINANCE

Rulin Safety An Ordinance to amend Sections 10.390, 10.470 and 10.490 of the Manitowoc Municipal Code to revise no parking zones on portions of South 15th Street, South 16th Street and Washington Street.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.390(a) is repealed and Sections 10.390(b) and (c) are renumbered as follows:

"10.390. Parking Prohibited. It shall be unlawful for the operator of any vehicle to park such vehicle in any of the places where parking is prohibited by Wis. Stat. Ch. 346, except to comply with the directions of a traffic officer or traffic control signal or sign, or to park upon any portion of the following designated streets or places:

South 15th Street. There shall be no parking on South 15th Street as follows:

- (a) On the west side of South 15th Street beginning at a point located 142 feet north of the north curbline of Washington Street and continuing north for a distance of 83 feet, except for the sole purpose of loading and unloading motor vehicles.
- (b a) On the west side of South 15th Street, beginning at a point located 120 feet south of the south curbline of Clark Street, thence continuing south a distance of 330 feet, except for the sole purpose of loading and unloading motor vehicles between the hours of 6:00 a.m. and 10:00 p.m.
- (e b) On the east side of South 15th Street, beginning at a point located 80 feet north of the railroad tracks on the north side of Franklin Street, thence continuing north a distance of 350 feet, between the hours of 6:00 a.m. and 10:00 p.m., except for the sole purpose of
- Section 2. Section 10.390(c) is repealed and Section 10.390(d) is renumbered and recreated as follows:

South 16th Street. There shall be no parking on South 16th Street as follows:

- (c) On the west side of South 16th Street beginning at the north curbline of Washington Street and continuing north for a distance of 35 feet.
- (d c) On the west side of South 16th Street beginning at a point 95 feet north of the north curbline of Washington Street continuing north to the south curbline of Franklin Street.
- (d) On the east side of South 16th Street beginning at the north curbline of Washington Street and continuing north for a distance of 140 feet.
- Section 3. Sections 10.390(f) and (g) are renumbered and Section 10.390 (f) is recreated as follows:

Washington Street. There shall be no parking on Washington Street as follows:

- (f) On the south side of Washington Street beginning at the west curbline of South 16th Street and continuing west for a distance of 140 feet.
- (f g) On either side of Washington Street from the west curbline of South 20th Street to the east curbline of South 22nd Street.
- (g h) On the south side of Washington Street from South 22nd Street to South 25th Street.

Section 4. Sections 10.470(a) and (b) are repealed as follows:

10.470. One-Hour Parking. No vehicle shall be parked for a continuous period of longer than one hour between the hours of 9:00 a.m. and 5:00 p.m., except on Sundays and holidays, on the following streets or portions of streets:

South 15th Street.

- (a) On the east side of South 15th Street from the north curbline of Washington Street for a distance of 130 feet to the north.
- (b) On the west side of South 15th Street from a point located 120 feet south of the south curbline of Clark Street, thence continuing south a distance of 150 feet.
- Section 5. Section 10.470(a) is repealed and Section 10.470(b) is amended as follows:

South 16th Street.

- (a) On the east side of South 16th Street beginning at a point 25 feet north of the north curbline of Washington Street, thence continuing for a distance of 60 feet.
- (b) On the west side of South 16th Street beginning at a point 35 feet north of the north curbline of Washington Street, thence continuing for a distance of 60 feet. the north curbline of Washington Street, thence continuing north for a distance of 95 feet.

Section 6. Sections 10.490(a), (b) and (c) are repealed as follows:

10.490. Two-Hour Parking. No vehicle shall be parked for a continuous period of longer than two hours between the hours of 9:00 a.m. and 5:00 p.m., except on Sundays and holidays, on the following streets or portions of streets:

South 15th Street.

- (a) On the east side of South 15th Street from a point 130 feet north of the north curbline of Washington Street to the south curbline of Franklin Street.
- (b) On both sides of South 15th Street between Franklin and Clark Streets.
- (c) On the east and west sides of South 15th Street in the 700 block between 7:00 a.m. and 7:00 p.m., Monday through Friday.

Section 7. Sections 10.490(b) is repealed and (c) and (d, are renumbered as follows:

South 16th Street.

- (a) On both sides of South 16th Street between Marshall Street and Washington Street.
- (b) On the west side of South 16th Street commencing at the north curbline of Washington Street for a distance of 120 feet to the north.
- (e b) On the west side of South 16th Street from Wollmer Street north to a point which is located 200 feet south of the southernmost railroad track located at the entrance to the Manitowoc Company property between the hours of 8:00 a.m. and 5:00 p.m.
- (d-c) No vehicles shall be parked for a continuous period of longer than two hours between the hours of 7:00 a.m. and 5:00 p.m., Monday through Friday, on the east side of South 16th Street beginning at a point located 102 feet north of the north curbline of Hamilton Street, thence continuing north a distance of 104 feet.
