**THIS IS AN ORDER** to reopen the Final Decision in this docket regarding the application of the City of Manitowoc, Manitowoc County, Wisconsin, as an Electric Public Utility, for Authority to Adjust Electric Rates. The Commission reopens this docket by its authority under Wis. Stat. § 196.39.

On June 17, 2014, Commission served its Final Decision in the application of the city of Manitowoc (applicant) as an electric public utility for authority to decrease electric rates. (PSC REF#: 206440.)

In that Final Decision, Appendix D Schedule of Depreciation Rates reflects a depreciation rate of 3.33 percent for plant account 391.1 Computer Equipment. The correct depreciation rate for this account is 33.3 percent. Correcting the depreciation rate will have no impact to the customer rates authorized. This order notifies all parties of the Commission's intent to correct the depreciation rate.
