

ACH Blocks/Filters Addendum

This ACH Blocks/Filters Addendum ("Addendum") to the Master Treasury Management Services Agreement (the "Agreement") sets forth for TIN:______ the terms and conditions that will govern your use of the ACH Blocks/Filters Services (the "Blocks/Filters Service") described herein.

- 1. Scope; Definitions. By signing below and through your use of the ACH Blocks/Filters Service, you agree to be bound by the terms and conditions hereof. It is understood and agreed that this Addendum shall supplement and is hereby incorporated into the Agreement. Unless otherwise defined herein, capitalized terms have the meanings ascribed to them in the Agreement. Any reference to "we", "us", or the "Bank" shall refer to Bank First National, and any reference to "you" or the "Company" shall refer to the company countersigning this Addendum below.
- 2. <u>Effective Date</u>. We will begin performing the ACH Blocks/Filters Service with regard to Automated Clearing House ("ACH") transactions beginning with your first statement cycle following the proper execution of this Addendum. We will continue providing you with the ACH Blocks/Filters Service until this Addendum is terminated in accordance with the terms of the Agreement.
- 3. <u>Description of Services</u>. You shall establish and provide to us criteria under which ACH debit transactions ("Debit") shall be paid from your account(s) listed in <u>Schedule A</u>. If Debit is presented to us for payment against your designated account which does not for any reason meet the established criteria, such Debit shall be deemed an exception. We shall deliver to you, by approximately 9:00 a.m. CST each Banking Day, an electronic list of such daily exceptions. All Debits noted on the exception list <u>shall be returned</u> unless you specifically instruct us to pay them, and such instruction to pay is selected on the exception list submitted to us by 12:00 p.m. CST.
- 4. <u>Counterparts</u>. This Addendum may be signed in counterparts, all of which shall constitute one agreement.
