


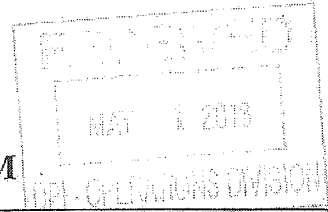

The parties agree as follows: Bookings must be made no earlier than 12 months in advance. The Permittee understands his/her responsibility is to set up, clean up and restore premises within the time period listed above.

Limitation of Use: Permittee agrees that the number of persons on the rented premises during the rental period shall not exceed the capacity of the facility and that no intoxicating liquor or fermented malt beverages shall be served to minors. Permittee agrees to use premises rented for the purpose stated above and no other. In the event this Limitation of Use is not complied with, Permittee shall be charged and agrees to pay a fee of \$200.

Northeastern Wisconsin Great Lakes Sport Fisherman Inc. have been granted use of the north parking lot area of the Manitowoc Marina by Rich Larson for our 44<sup>th</sup> annual Salmon Derby July 6-8 and 4<sup>th</sup> on the Shore on July 4.

We would like an extension of the noise ordinance for Friday July 6 and Saturday July 7 until 11:30 PM. AS in past years we requested and received from the Parks Department picnic tables and garbage cans at no cost. Once again we are formally requesting the support of the city which has been offered in previous years. WE would also request from the Recreation Board permission to sell fermented beverages until 11:30 PM in the north parking lot of the Manitowoc Marina. We hope favorable consideration will be given to these requests.
