Troy,

Matt Smits and I met with Chris Allie this afternoon. We had quite a tour of the property.

I asked him about the brick pavers.

He does not want to lose them.

He wants DOT to minimize any removal of the pavers.

He definitely objects to the concrete pavement. He wants the pavers kept as is.

Chris stated that he met with Pam Anderson (DOT Real Estate Appraiser??) last Friday to discuss somethings, but he did not feel that there was any "official agreement".

He also stated the he absolutely wants the chain link fence replaced along Waldo Blvd.

I have also attached an e-mail with some photos of the issue we met with him about. It is not a DOT issue and may not even be a City issue. There is quite the erosion problem. Chris stated that the dam in the photo was built by the Conservation Corps. in the 1930's.

He claims that all of this major erosion has occurred within the past 1-2 years. I would have to believe him because he is not shy about bringing issues to the City. He has owned the property for about 14-15 years he said.

This property was formerly owned by Guido Rahr who owned the Rahr Farm and Malting business.

My guess is that this issue will go before the PI Committee to see what they think. It may well be a private issue for him.
