Sonja,

Dan and I met with Gary this morning.

This driveway request needs to be put on the August 3rd PI Committee Agenda as it will exceed the normal 35 foot width for a commercial driveway.

Sadoff Iron and Metal will be installing a new above ground scale and they will need to install a new driveway off of South 26th St.

They will need a 63 foot wide curb cut for the new scale and for the truck turning movements.

Since this scale is for weighing trucks including low boys, we suggested that they install a curb returned driveway in lieu of the traditional trapezoidal driveway approach.

See the attached drawings for the approximate location of the new driveway.

They are planning to do the work later in August.

We told Gary that his contractor will need to obtain a \$40 New Driveway Permit.





