You are hereby notified that a Complaint has been received by the City of Manitowoc, pursuant to Wis. Stat. §125.12(2), requesting the revocation or suspension of the above referenced Class "B" Retail Intoxicating Liquor and Fermented Malt Beverage License for reasons stated in the Complaint, a copy of which is attached hereto.

Pursuant to Wis. Stat. §125.12(2)(ar), you are commanded to appear before the Finance Committee of the Manitowoc Common Council in the First Floor Conference Room of City Hall, 900 Quay Street, Manitowoc, Wisconsin at 5:30 P.M. on Thursday, February 9, 2017, and show cause why Scorpion's Class "B" Retail Intoxicating Liquor and Fermented Malt Beverage License should not be revoked or suspended.

If you do not appear as required by this Summons, the allegations of the Complaint shall be taken as true, and if the Finance Committee or the Manitowoc Common Council find the allegations sufficient, your Class "B" Retail Intoxicating Liquor and Fermented Malt Beverage License shall be revoked.

COMPLAINT

d/b/a Scorpion Bar and Grill 214 N. 8th Street Manitowoc, Wisconsin 54220

Pursuant to Wis. Stat. §125.12(2)(ag), Scott Luchterhand, Deputy Chief of Police, being first duly sworn, complains that the Class "B" Retail Intoxicating Liquor and Fermented Malt Beverage License of the above named Licensee should be revoked or suspended for the following reasons:

- 1) The person has violated this chapter or municipal regulations adopted under §125.10.
- 2) The person keeps or maintains a disorderly or riotous, indecent or improper house.
- 3) The person does not possess the qualifications required under this chapter to hold the license.

The factual basis for my complaint is as follows: A check of the City of Manitowoc Police Department records indicate that Scorpion Bar and Grill, LLC (Scorpion) has been the site of numerous serious incidents which substantially relate to the circumstances of the licensed activity. For instance, on December 31, 2016, an aggravated battery occurred outside Scorpion. The victim and her partner were patronizing Scorpion at the time of the incident. The victim, while smoking a cigarette outside the main entrance, was attacked with a broken beer bottle. Her substantial injuries required approximately thirty (30) stitches. No one from Scorpion contacted authorities at the time of the incident. Rather, law enforcement was notified by medical staff attending to the victim.

On July 31, 2016, another physical assault occurred at Scorpion involving approximately

five or six individuals who attacked a victim while inside the bar. No one from Scorpion contacted authorities at any point during the altercation. Law enforcement only learned about the event through the medical facility treating the victim for his injuries. In addition to the abovenoted assaults, the following citations were issued in 2016 and 2017:

During these citing incidents, Mr. Ibarra and his daughter, Geraldine, a managing bartender at Scorpion, expressed a lack of concern for abiding by City ordinances and Wisconsin

laws. Moreover, Mr. Ibarra displayed an unwillingness to cooperate with law enforcement or to contact law enforcement when reasonably necessary. This behavior is inconsistent with the responsibilities granted by Mr. Ibarra's Class "B" Retail Liquor License and Operator's License. For purposes of clarification, I have included copies of the police reports relating to police contacts at Scorpion from 2016.
