Can you get me some traffic accident data for the intersection of S. 10th and Dewey St.

I do not necessarily need the accident reports, but I would like to know how many accidents there have been in the past 5 years.

Last night we held a public informational meeting for the S. 10th St. reconstruction and the property owner on the southeast corner of the intersection stated that there have been numerous accidents at this intersection.

He said that people come down the hill (eastbound direction) and are blowing the stop sign. He would like to see an LED flashing light installed as part of our reconstruction project.
