Request to Rescind Snow Shoveling Special Assessment for Parcel 412-004-080

There have been some issues with the interface between Springbrook and the Assessor's site. As a result, we have had some instances where incorrect property owners were notified of a sidewalk shoveling violation. Parcel #412-004-080 is one of the properties affected.

The violation notice was sent out on January 16, 2017 to Mr. and Mrs. Parnau, the former property owners. The invoice for sidewalk shoveling also went to Mr. and Mrs. Parnau. Mr. Parnau contacted us to let us know he was no longer the property owner and has not owned the property since November, 2016.

Since the new property owner had not been notified of the violation, we recommend rescinding the \$300.00 snow shoveling invoice.

#### SIDEWALK VIOLATION NOTICE

Dear Property Owner:

This is to notify you that the City of Manitowoc Department of Public Infrastructure has received a complaint that your property at, parcel #412-004-080 (943 N 8TH ST) is in violation of City of Manitowoc Ordinance 7.21 (1). This ordinance states that snow and ice must be removed from the full paved width of the sidewalk by the property owners, lessees and occupants.

If snow/ice is not removed from the full paved width of the sidewalks within three (3) days of the date of this notice, the City will clean the sidewalk and costs will be assessed to the abutting property owner. Sand or salt may be used for ice control on sidewalks.

The minimum assessment for snow/ice removal on any city sidewalk <u>in a three year period</u> shall be assessed as follows: 1<sup>st</sup> violation-\$300, 2<sup>nd</sup> violation-\$600, 3<sup>rd</sup> and subsequent violations-\$900. For any work longer than 60 minutes per violation, there will be an additional charge for labor and equipment (over and above the violation fee).

You will <u>not</u> receive any future violation notices. Your sidewalk will be cleaned and assessed per occurance if not in compliance with Manitowoc City Ordinance and resolutions.

Your cooperation with cleaning your sidewalk is greatly appreciated.

For your information, enclosed is a copy of the ordinance pertaining to snow/ice removal from city sidewalks. If you have any questions on this matter, you may call (920) 686-6550.
