ORDINANCE

An Ordinance to amend Section 22.010 of the Manitowoc Municipal Code regulating "Official Map – Master Subdivision Plans".

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 22.010 is amended to read as follows:


"The Official Map System of the City of Manitowoc is herewith amended being in the Northeast ¼ of the Northwest ¼ Section 29; also the Southeast ¼ of the Southwest ¼ Section 20, Northwest ¼ of the Southwest ¼ Section 20, Northwest ¼ of the Southwest ¼ Section 20, Southwest ¼ of the Southwest ¼ Section 20, Southwest ¼ Northwest ¼ Section 20, Northwest ¼ of the Northwest ¼ Section 20; also the Northeast ¼ of the Southeast ¼ Section 19; also the Southwest ¼ of the Southwest ¼ Section 17, Northwest ¼ of the Southwest ¼ Section 17 all being in Township 19 North, Range 24 East, City of Manitowoc, Manitowoc County, Wisconsin and all according to the attached map."

Section 2. This ordinance shall take effect the day after publication.




