COMPLAINT

NOW COMES plaintiff, Brenda Marie Hawpetoss, by her attorneys, Nash, Spindler, Grimstad & McCracken LLP, and hereby allege the following facts and claims:

GENERAL ALLEGATIONS

- 1. That plaintiff Brenda Marie Hawpetoss is an adult resident of the State of Wisconsin residing at 1032 South 10th Street, Apartment B, Manitowoc, WI 54220.
- 2. That defendant, City of Manitowoc, is a domestic corporation, whose primary business address is 900 Quay Street, Manitowoc, WI 54220, whose registered agent is the City

Clerk, Jennifer Hudon, 900 Quay Street, Manitowoc, WI 54220, and operates the City's transit services.

- 3. That defendant, Maritime Metro Transit, is a domestic corporation, whose primary address is 915 South 11th Street, Manitowoc, WI 54420, whose registered agent is Transit/Buildings & Grounds Division Manager, Jim Meunzenmeyer, 915 South 11th Street, Manitowoc, WI 54220, and operates the City of Manitowoc's transit services.
- 4. That defendant, Ronald Shannon, is upon information and belief, an adult resident of the state of Wisconsin, whose last known business address is 915 South 11th Street, Manitowoc, WI 54220, whose present home address is presently unknown, and who was, at all times material hereto, an employee of defendant Maritime Metro Transit as a permissive user of the bus on the day of the accident.
- 5. That defendant, Transit Mutual Insurance Corporation of Wisconsin, is a domestic insurance corporation, licensed to do business in the state of Wisconsin, whose primary address is 400 North Richmond Suite J, Appleton, WI 54912, whose registered agent is Amy Eckes, 400 North Richmond Street Suite J, Appleton, WI 54912, and which had, at all times material hereto, issued one or more policies of insurance to defendants, City of Manitowoc and/or Maritime Metro Transit.
- 6. On or around November 18, 2016, at approximately 2:40 p.m., a bus operated by the City of Manitowoc and/or Maritime Metro Transit through its employee Ronald Shannon, in the City of Manitowoc, Manitowoc County, at 3415 Calumet Avenue, negligently ran over a curb in the parking lot of Planet Fitness.
- 7. As a result of said negligence, plaintiff fell out of her seat, and was a substantial factor and proximate cause of the accident and injuries and damages which have resulted from it.

- 8. As a direct result of the accident described above, the plaintiff, Brenda Marie Hawpetoss, suffered severe and permanent injuries to her mind and body. These injuries have in turn caused her to experience pain and suffering, interference with her normal activities, interference with her ability to enjoy life, interference with her ability to earn income, and have caused her to incur medical expenses, lost wages and other expenses, all of which will continue on a permanent basis in the future.
- 9. That defendant, City of Manitowoc, is liable for the negligence of its driver, Ronald Shannon, under the doctrine of respondeat superior.
- 10. That defendant, Maritime Metro Transit, is liable for the negligence of its driver, Ronald Shannon, under the doctrine of respondent superior.
- 11. That defendant, Ronald Shannon, was negligent with respect to the operation of the bus and his negligence and carelessness was a substantial factor in causing the accident referred to above.
- 12. That defendant, Transit Mutual Insurance Corporation of Wisconsin, is liable to plaintiff by virtue of the policy of insurance as herein alleged.
- 13. Plaintiff, Brenda Marie Hawpetoss, complied with Wis. Stat. § 893.80(1d)(a), by filing a Notice of Circumstances of Claim and Claim on February 1, 2017, which is attached hereto as Exhibit A.
- 14. Plaintiff, Brenda Marie Hawpetoss, received a Notice of Disallowance of Claim from the City of Manitowoc on March 6, 2017, which is attached hereto as Exhibit B.
- 15. Plaintiff, Brenda Marie Hawpetoss, did not receive a Notice of Disallowance of Claim from Maritime Metro Transit.

WHEREFORE, plaintiff demands a trial by jury and judgment against the defendants as follows:

- 1. Against the defendants for the amount of compensatory damages found to be appropriate, together with the costs and disbursements of this action; and
 - 2. For such other further relief as the Court deems just and proper.
