Hello Greg,

The area on Paul Road, greater than 1000 feet south of Joseph road, is equipped with ornamental, "coach light" style lights. There are utility poles in the segment 700 feet south of Joseph Road, but they are not capable of supporting non-ornamental lights.

For effective lighting of the 700 foot segment, MPU recommends 2 each, "coach light" style lights. Estimated installation cost is 3,200 (2 x 1600 each), which should be ordered per the process identified by City Ordinance 12.150(2).

Ald. Rhienna Gabriel received a complaint about the lack of street lights on Paul Rd. from Joseph Rd. to approx. 700 feet to the south.

In the areas of Paul Rd., Joseph Rd., and Virginia Dr. there is a combination of the normal subdivision coach lights and the normal non-ornamental lighting (on wood poles).

What would be your recommendation for this unlit area?? I am guessing just putting in a few lights on existing or new wood poles would be the easiest and cheapest solution.

I believe that this issue may be on the Public Infrastructure (PI) Committee Agenda for October 11th.

If they want to move forward with this, we will need a resolution to be approved by Council prior to installation.
