I am not exactly sure what County Executive Ziegelbauer's past roles were — I know that at one point he held two elected offices, which was not statutorily incompatible at the time, and that at another time he was employed by the City while running for an elective office with another jurisdiction, but that is not prohibited. The statutory prohibition is specific to local government elected officials holding an elective office and a paid position for the same local government. For example, our County Board Supervisor Zimmer could not apply to be an Economic Support Specialist with the County. There is nothing precluding him from applying for a job with the City or the State, but he could not hold a county position.

Good afternoon Alder Gabriel,

I was able to locate my old files on compatibility of offices, and also spoke with Attorney Buerger at the Ethics Commission and Attorney Daniel Olson at the League of Wisconsin Municipalities. While there is nothing in the local officials ethics code that directly prohibits an alderperson from applying for a City position (seasonal or

otherwise), there is a statutory prohibition on this due to incompatibility of offices. Wis. Stat. § <u>66.0501 (2)</u> specifically prohibits members of a council from being eligible from any office or position with the City that is a non-elected position. There are a few very specific exceptions for volunteer and EMS personnel, but those do not apply here as we do not have any type of seasonal positions of that nature. The League of Wisconsin Municipalities also issued a helpful FAQ Question, <u>Compatibility of Offices 1</u>, that addresses some of the case law on point.

The City has historically taken the position that an alder who wishes to apply for a position with the City would need to resign their position in order to apply. No alder has ever chosen to do that, so we have not explored it further. If you would like a full opinion of the Ethics Board or the Personnel Committee, Alder Sitkiewitz would be the person to put those on the agenda for you.
