Inclosed is the information we have on hand.



PROPOSED HOUSE AT 1418 No. 3RP. ST.


NOTES :

INSTALL A SINGLE ACCESS DRIVE USING 2 TO 3 INCH AGGREGATE 6 INCHES DEEP AND 7 FEET WIDE FROM THE FOUNDATION TO THE STREET TO PREVENT TRACKING DIRT ONTO THE ROAD BY ALL VEHICLES AND SHOULD BE MAINTAINED THROUGHOUT CONSTRUCTION.

ALL OFF-SITE SEDIMENT DEPOSITION OCCURRING AS A RESULT OF CONSTRUCTION ACTIVITIES SHALL BE CLEANED UP AT THE END OF THE WORK DAY AND ALL OFF-SITE SEDIMENT DEPOSITION OCCURRING AS A RESULT OF A STORM SHALL BE CLEANED UP AT THE END OF THE NEXT WORK DAY.

SITE TO BE TOPSOILED, SEEDED AND MULCHED OR SODDED BY OWNER AT THE COMPLETION OF CONSTRUCTION.
