Subject: Possible Half-Penny Sales Tax Public Inputs Compiled 12/2017-09/2018

Hello, Municipal Clerks,

It's budget time again, when our County Executive proposes his budget for the upcoming fiscal year. He'll do that at next Tuesday's County Board meeting.

In 2017, our county borrowed \$9,995,000. In 2018, our county borrowed \$1.5 Million. During the September Finance Committee meeting, plans were mentioned for approximately \$5 Million more to be borrowed.

The most recent state estimate of our county's anticipated revenue from a half-penny sales tax is \$5.3 million dollars per year.

Over time, as I have studied and learned about this issue, I have concluded that I support the half-penny sales tax as the most economical, fiscally conservative way to meet our county's growing fiscal needs.

There are numerous systemic factors that have put us in our current indebted position, among them: the inflation rate, state-mandated levy limits, and reductions in both transportation aids and state aids to the county.

Property tax relief from a half-penny sales tax is a good thing, enjoyed by slightly more than 90% of WI counties.

The half-penny sales tax would provide an estimated property tax relief of \$1 dollar per thousand dollars of a property's equalized value.

There are 49,067 taxable property parcels in Manitowoc County. Those property owners would benefit from lower property taxes, and many may be among our county's 43,306 registered voters.

County Board Chairman Brey and Finance Committee Chairman Hansen are establishing an ad hoc committee to draft a proposed resolution on the half-penny sales tax for presentation to the Finance Committee and possibly, the full county board of legislators.
