Deborah,

The exemption for Parcel #000117050, 435 N. 8th St, Manitowoc was improperly removed in 2018 which resulted in a tax bill to be generated. The parcel was being used as a Jewish Synagogue until October, 2018. The name of the congregation was ANSHE POALE ZEDEK CONGREGATION, A/K/A ANSHA PALIA SADIK. The assessors' office had been told that the property was no longer being used as a synagogue and the building was vacant and up for sale. We visited the property and saw no evidence that the congregation was still operating. The exemption was pulled, the building was assessed, and a tax bill was generated.

It was brought to our attention by the new owner, Michael Merrill that the congregation was indeed functioning until October, 2018 after he received a tax bill. This was confirmed by Howard Zimmerman, a leader of the synagogue. The property was exempt for 2018 and a tax bill should not have been generated.

This is an assessor's error.
