Good Morning Amber,

Thank you for your prompt reply! It is greatly appreciated. I am writing to you and the members of the Public Safety Committee regarding the Jackson Elementary school drop off & pick up situation. Jackson Elementary is a school where several students are able to walk, but after almost 3 years of having a daughter attend I have noticed there is a need for an evaluation to be done regarding the safety of the students during school drop off (8:20 AM - 8:40 AM) and school pick up (3:40 PM). Jackson appears to have a unique problem with car congestion as there is no official and safe place, on school grounds, to drop off children driven to school.

These are the following drop off options:

Cul-de-sac on North 17th

- o This is the only spot that allows students to safely leave the vehicle and enter the playground where Jackson employees monitor the children
 - Without crossing traffic
 - without an added expense of a cross guard
- o This is a road that is considered a side street and doesn't receive a ton of attention when it comes to snow removal in the winter
- o This is a road that also have a ton of leaves in the fall, and leaves the street as narrow as it becomes with snow piles in the winter
- o This is a road that doesn't have parking restrictions and allows people to park on both sides of the street (see attached photo)
- North 18th Street
 - o Which requires parents to pull over before they get to school property (if they are on the east side of 18th)
 - o Or, requires students to cross 18th (from the west side) and, only two available crossing guards
 - One on the corner of Menasha and 18th
 - One on the corner of Waldo and 18th
 - No cross guards available to students who's parents park adjacent to Jackson
- Menasha Ave.
 - o Student crossing guard helpers whose parents park in the Redeemer Church parking lot
 - o This requires students to cross the parking lot where teachers and support staff park
 - Most children are not visible in this situation to those pulling into and out of parking spaces

What I am asking for:

- An immediate review of parking restrictions during the school year on North 17th
 - o Maybe parking is available on the east side of the street on even days and west on odd days
 - Snow and leaf removal on a more regular basis
 - Snow removal (this becomes a main street)
