Hi Justin.

I received a bill today from the city for snow removal, but I'd like to explain the circumstances—and appeal.

I left on February 8th to go out of town for 12 days. The company that has removed my snow for years told me in mid November that they were retiring. I desperately sought someone else which was almost impossible at that late date. I hired one person who did it a few times and then stopped coming. Just before I left, I hired another person who removed the snow at that time and promised he'd take care of it while I was gone. I had no access to email for a week, but found out later that he never came back. Jeff Brown (Catherine Leone's husband) and Al White noticed this then came over and removed the snow. In fact, Al sent me a picture of the cleared sidewalks on the 18th. I returned on the 20th and saw the sidewalks had been shoveled.

On the 21st, Catherine Leone dropped me off in front of my driveway and I noticed two strangers, a man and woman, spreading something on a section of my sidewalk. As I approached them to ask who they were, they turned and walked quickly away to a truck across the street (with the Eco sign). I waited to talk to them, but they drove away. I called a third person and have hired him and so far, he's shown up and done the job (Will Schmidt).

I was surprised to get the city bill, as the snow had been cleared before they came on the 21st. I'd like to ask you to reconsider the fine imposed.
