

All,

Sometimes I try to take a 30,000 foot look at something and see if it looks any different....

- 1. We want to encourage sidewalk food and beverage service.
- 2. We don't want underage drinkers or people walking the streets with liquor.
- 3. We've got laws to govern walking the streets with liquor and underage drinking.
- 4. We have an ordinance that suggests a fence OR barrier to combat the above said on sidewalks.
- 5. City Planner approves barriers. (in this case, Harbormaster, one in the same, so the barrier / fence may have a nautical theme)

All kidding aside, any applicant comes to CD. We review. The ordinance does not say whether the barrier is physical or not. Why not a visual barrier? Satisfies intent of the ordinance, still enforceable. In a case like Petskull, it's a sidewalk café where maybe 7-10 people could sit outside – visual barrier. In case like the Wharf, there's potentially 100+ people – fence is the appropriate barrier. Either way, CD reviews.

Both stymieing progress and or ignoring an ordinance seem counterproductive. Commonsense middle ground?

Looks like the City's sidewalk café ordinance FAQ online provides the following:

Can alcohol be served on a Sidewalk Café Permit? The City of Manitowoc allows alcoholic beverages to be served in outdoor cafés; provided, that the permittee complies with all the requirements for obtaining an alcoholic beverage license, and the sidewalk cafe is listed on the alcohol beverage license application as being an extension of the licensed premises. For more information on serving alcohol on a sidewalk café, contact the City Clerk at 920-686-6950. Hopefully all have listed the outdoor areas on the alcohol beverage licenses they have.

(2) Any person convicted of the violation of this section shall be required to forfeit not more than \$200.00 for each offense.

I approve the sidewalk café permit that was requested.

As we discussed briefly (Mackenzie and I), I plan to reach out to the Mayor to ask if there is a possibility of allowing staff (Comm Dev & PD) approval of sidewalk café's (and amend the ordinance). Seems to be overkill to have this go to Finance and Council when our departments can look at the apps and technical items to ensure safety, pedestrian accessibility, etc.. Not sure what Finance and council would even be looking at? All it does is delays the process

Ordinance does say the following: (i) Sidewalk cafes where alcohol beverages are sold shall have fencing or barriers on at least three sides. The barriers shall define the area where the alcohol beverages may be served and consumed. The barriers shall be approved by the City Planner or designee as part of the application process;

So I will have Paul work on that part – sorry, I didn't see that one at the end of the ordinance! (here is link to the sidewalk café info). Can Paul or MacKenzie reach out to the applicant to let them know they need the barriers per the

From what I can see there is no fence or barrier around this area where they plan to serve alcohol. I have a concern about how they will control underage drinking and also without a clear physical barrier how will people be able to understand where they can and cannot have open intoxicants? We have an ordinance about drinking outside of a tavern so we need to have a clear understanding of the area:

14.530 Possession or Consumption of Alcoholic Beverage in Front of Taverns – Penalty.

(1) No person shall consume alcoholic beverages or possess an open container of alcoholic beverage in front of a Class B liquor and beer tavern premises. In addition to cans and bottles, container shall include a cup, glass and all other vessels which contain any amount of alcoholic beverage. The expression in front of shall mean the immediate area in front of the tavern and the area in close proximity to the tavern. The purpose of this section is not to prohibit a resident from consuming an alcoholic beverage in front of their residence, but is to prevent patrons of a Class B liquor and beer tavern premises from carrying, possessing, and/or consuming alcoholic beverage outside of the tavern. This section does not apply to water or soft drinks but only to those drinks which contain alcoholic beverage or beer.

substantially and we want to encourage sidewalk café's in the downtown; we need to not make it such an ordeal to get approval if we want businesses to do these things.

Also – I don't believe anyone is really policing the sidewalk café's to ensure all have permits – seems most just do it and never get the permit? In this case, with Ryan's doing the right thing and following the process, they couldn't even get on the finance agenda until the first week in July and then Council the 3rd week in July, and would miss half the summer before they can put tables out.

Nick (with a gun) what are your thoughts on our two departments signing off – would you support that? I may be missing something with why it currently goes to finance an council.
