Dear Sir or Madam:

I and my wife (Eileen) are the owners of 411 State Street, Manitowoc. This is our second residence and we have a snow removal service. Somehow our snow removal service missed the snow shoveling, resulting in snow removal services provided by the City on 3/13/19 (attached is the \$300 invoice and our property tax bill showing such assessment). At the time of the service, our pipes had frozen and we had substantial damage to the house due to broken pipes. Everything was in chaos.

Immediately after receipt of the \$300 bill, my wife checked the City's web site, which contained regulations relating to the assessment of snow shoveling fines. The online materials clearly stated that the property owner must receive a 3-day notice before the fine would be assessed. We never received such notice. My wife then called up the legal department and asked to speak to an attorney. She talked to "Jane" in your

My wife then called up the legal department and asked to speak to an attorney. She talked to "Jane" in your legal department and explained that we never received the required 3-day notice. Jane stated that the website "should have" been amended to reflect that the 3-day notice was stricken. Yet at the time the fine was issued, such notice requirement was clearly present online. But magically after my wife's phone call, the City's website was updated deleting the 3-day notice requirement.

Under the above circumstances, can the \$300 charge be abated? Our defense is that we were not given the required notice. If your regulations were changed, what was the effective date? If the effective date was after the snow removal service, we should not be charged. If before, why should we be charged if the City did not notify the public of this change in the first place?

A timely response to this abatement request would be appreciated.



What I can tell you this far, is that I did an extensive line by line search of the history log for the Snow & Ice Control page of the website and the Sidewalk Snow Removal page of the website and did not find that any changes had been made to these pages within the time frame we were looking at. Just to be sure, I contacted Civic Plus to determine if there was something further I should be searching, and it was determined and confirmed that these specific pages have not been changed since 2017.

On the Sidewalk Snow Removal page of the website (page 376), there is an outdated press release that I would suggest DPI Administrative staff remove or at minimum update - it's a 2017/2018 Snow Information Press Release. I reviewed that press release (here's a link to it), and I don't see anything in regard to a 3 day notice.

Did this policy possibly change sooner than you may have thought it did?

I don't know if this would be helpful, but I'm able to print the full log (which is unable to be altered) as proof if necessary. But the complainant would need to be able to tell us exactly where his wife saw the information. Without that, I don't know that I can search any further.

Any newly fallen snow or newly formed ice which is on any such walk at 6:00 a.m. of any day shall be removed from such walk by 8:00 p.m. of the same day; provided, that where footways or sidewalks have not been paved or duly established, snow and ice shall be removed to a width of not less than four feet from that portion of the street or way which is used in common as a footway.
- (6) Duties of Director of Public Infrastructure. It is hereby made the duty of the Director of Public Infrastructure or person performing the duties of that office to cause each such sidewalk mentioned in subsection (1) of this section to be cleaned of snow and ice or properly sanded or sprinkled with an equivalent thereto, in each case where the owner abutting the premises has refused or neglected to perform the duties in respect thereto rendered on him by subsection (1) of this section and the prevailing cost of the same to be assessed against the owner.
