Regarding these two concerns, I think you could go back to the resident to let them know that after reviewing the street, there really seems to be adequate signage for no parking on Manilla and 10 street. I do not think it would be approved to put 2 "no parking from here to the corner" signs within a 50 foot area. If someone is parking there, that should be reported to the police as illegal parking.

I did go through there a couple times this week and there was no illegal parking and barely anyone parked on of those streets intersecting 10th street.

For the snow removal, there is a fairly new process that started last year were unless otherwise posted, we do not ban parking until the Mayor calls for a snow emergency. At this time cars must be pulled of the street and can return once the Mayor lifts the emergency. This is why signs are no longer placed on the streets.

Let me know if you want to discuss anything further with me or feel you wan to bring these for any committee action.

As a follow-up to these requests, I took some time to go over to 10th and Manilla again yesterday around 7:30am to check out the parking. Like my last visit over there, I only observed a few cars parking on Manilla.

The stretch of 10th street north of Manilla is clearly mark No Parking. I headed west on Manila and there are no parking sign down the northside of Manilla. Coming back east, there were a few cars parked and the last 40 feet or so of Manilla that is clearly marked no parking and leaves plenty of visual clearance. If people are parking there, it is illegal.

As far as winter plowing, I assume the reason for no parking on the northside is to keep clearance for traffic all the time since it is narrow.

A declared snow emergency would mandate cars have to be moved off the street vs. the signs and restrictions that we formerly placed on the streets before the changes made last year. Please confirm this.
