
2020 Budgeted Expenditure Amounts



Station Information

The City of Manitowoc has four Fire Stations located throughout the city.

Fire Station 1

Built: 1991

Fire Station 1 is located at 911 Franklin Street, in the City of Manitowoc's Public Safety Building. It houses one Ladder truck, one Rescue Engine, two Advanced Life Support (ALS) Units, one Technical Rescue vehicle, one Wing Inflatable watercraft, and two utility vehicles.



Fire Station 2

Built: 1957

Fire Station 2 is located at 1410 North 8th Street, on the City's northeast side. It houses one Rescue Engine and one Advanced Life Support (ALS) Unit.



Fire Station 3

Built: 2001

Fire Station 3 is located at 3820 Dewey Street, on the City's southwest side. It houses two Rescue Engines (one in reserve status) and two Advanced Life Support (ALS) Units (one in reserve status).



Fire Station 4

Built: 1999

Fire Station 4 is located at 1125 Fleetwood Drive, on the City's northwest side. It houses one Rescue Engine and two Advanced Life Support (ALS) Units (one in reserve status), one 21 foot Water Rescue Boat, and a Survive Alive Trailer (SAT).









Incidents Responded to - 5 years





Fire Loss Data




Simultaneous Calls



Throughout the year 24 or **3.13%** of the total 766 Fire calls happened simultaneously.




EMS Calls vs Transports

Calls vs Transports - 5 years



Division of Life Safety and Neighborhood Services

Purpose

The Building Inspection Department is dedicated to public safety in the construction environment throughout the city through development and promotion of uniform codes and standards, code administration, and in education and instruction of safe and secure residential homes and businesses.

Services

The Building Inspection Department is customer focused and provides a public service window, open during City Hall business hours. Services involve all permit activities including screening application/plans, routing plans to an inspector for review, technical assistance, assessing and collecting fees, and conducting permitted inspections. In addition, department services include building condemnations, court testimonies, and property maintenance inspections. The Building Inspection Department works closely with Community Development, Planning, Engineering, Utilities, and Fire/Rescue departments during the final inspection phase of the project and with the City Attorney's Office during criminal and fire investigations.

Enforcement

The Building Inspection Department has adopted the State of Wisconsin Building, Mechanical, National Electric Code (NEC), and Plumbing Codes. Through the adoption of these codes, the city ensures that all permitted projects in the city are compliant with the requirements of the State of Wisconsin.


Residential Permit Activity

In 2020, 23 new residential structures were constructed creating 77 dwelling units. Valuation of new residential construction totaled \$8,980,603. 571 residential properties underwent building renovation during 2020. The estimated valuation of this work was \$7,179,480. These projects included additions, decks, accessory structures, re-roofing, re-siding, window replacement, interior and/or exterior alterations and miscellaneous remodeling. Residential renovation accounted for 14% of the total annual valuation.

Permitted Inspections

Total Inspections: 3,471

Inspections are performed by state certified inspectors to assure compliance with code requirements and approved plans submitted for permits. Inspectors provide public safety by enforcing municipal state codes relating to construction, alteration, and installation of electrical, mechanical and plumbing equipment and systems. Inspections include site, foundation, footers, structural, electrical, air conditioning, ventilation, heating, insulation, windows, and doors. Inspections are carried out periodically throughout all construction phases until a certificate of occupancy is issued. The number of inspections completed for 2020 was approximately 17% lower than in 2019 due to COVID-19 restrictions.


Permitted Plan Reviews

Total Plan Reviews: 393

State certified inspectors provide technical plan review of proposed construction plans and documents to verify conformance with structural and non-structural code requirements. These projects can include new buildings, alterations, additions, and repairs to existing structures and signage. Inspectors conduct reviews in a timely, consistent, professional and courteous manner for each application. When necessary, preconstruction meetings are conducted for code interpretations and to resolve major code issues on larger projects prior to issuance of the permit. The number of plan reviews completed for 2020 was approximately 7% higher than in 2019.

Demolition/Razing of Structures

In 2017, the City of Manitowoc initiated a Blighted Property Restoration Program. The purpose of the program was to mitigate the impact of blight and promote neighborhood revitalization by demolishing those structures that are beyond repair and to reduce the negative impacts of structures that have become unsafe or constitute a public nuisance.

Minimum Housing & Property Maintenance Code Enforcement

Our Department is responsible for maintaining community compliance to protect the health, safety, and welfare of residents. Inspectors respond to calls regarding minimum housing and property maintenance concerns prioritizing their response to compliance issues with immediate threats to life-safety and public health. Per the US Census Bureau there are approximately 14,704 households in the City of which 66% are owner occupied.

In 2020, 445 new housing and property maintenance issues were received. A total of 3,785 actions were dedicated to compliance enforcement of new and existing issues. At the close of 2020, 488 new and existing cases were compliant and 97 citations were issued for non-compliant issues.



Compliance Issue Prioritization

- 1. Life Safety Issue: This issue places the public in imminent physical danger.
- 2. **Public Health Issue:** This issue exposes the public or property to substantial risk of disease, infestation of other unsanitary conditions.
- 3. **Unknown Issue:** This issue must be investigated to some level to determine if it places the public in imminent physical danger or exposes the public or property to substantial risk of disease, infestation of other unsanitary conditions.
- 4. **Performance on Zoning or Permits Issue:** This issue results from a permit or other approval by the city where staff are obligated to enforce codes.
- 5. **Neighborhood or Business Deterioration Issue:** This issue is neither a life-safety issue nor a public health issue but contributes to the deterioration of a neighborhood or business district.




