I. CALL TO ORDER

V. REFERRALS FROM COMMON COUNCIL

PC 21-2017: Review of Properties in Tax Foreclosure, recommending placing on file except the Summit St. pond at 6008 County Hwy LS and refer it to Public Infrastructure Committee to see if they are interested in pursuing this property.

T. Caulum presented the list of Tax Foreclosure Properties submitted by Manitowoc County. T. Caulum stated the City has no interest in any of the properties with the exception of a parcel that has a storm water pond located on it. The property is located at the northeast corner of Summit and S. 19th Streets and is owned by Summit Pond, LLC. T. Caulum referred to the Director of Public Infrastructure, Dan Koski for a recommendation on the storm water pond property.

D. Koski recommended the Plan Commission refer the Summit Street, LLC storm water pond property to the Public Infrastructure Committee for further discussion on the City potentially acquiring the property.

Moved by Koski, seconded by Steinbrenner, to refer the Summit Street, LLC storm water pond property to the Public Infrastructure Committee and to place the remaining foreclosure list on file. The motion carried by the following vote:

P. Braun explained that the original Home Occupation Conditional Use Permit was issued to Katelyn Scheck in 2015 for the operation of an in-home pet sitting business at 2019 S. 9th Street. P. Braun is recommending to remove the annual review and if any issues would arise in the future the Plan Commission could still review the conditional use permit at that time.

The lots were originally created by a certified survey that is recorded in Volume 32, Page 291. A utility and drainage easement, created by the survey, runs along the common lot line and needs to be released to allow for the construction of the residence. P. Braun stated that all the utilities have authorized the release of the easement and that there are no issues with the release.
