- 2016-3890 03-23-16 Complainant stated had three dollar bills sitting on bar intended for dancer. Another dancer requested the tip and subject said no. Dancer threw liquid of drink into subject's face. Subject's eyes was injured. Dancer was issued citation for DC.
- 2016-4380 04-01-16 Bar manager reports dancer was upset with dance time on stage. When bar manager confronted dancer, dancer began yelling at bar manager.
- 2016-5638 04-27-16 Dispatched to Goldiggers, 924 Washington Street, for report of a Disorderly Conduct. The caller who stated that earlier in the evening, another dancer was upset with her because she was making more money than she was. Caller said she was afraid the person was going to assault her if she tried to leave the building and she wanted police to give her a ride back to Milwaukee.
- 2016-7841 06-08-16 Husband came into the bar while she was playing pool and thought she was flirting with another guy. Subject stated husband began yelling at her but calmed down. she did not want her husband out of the bar. Husband stated he entered the bar to see his wife flirting with another guy so he got angry and began yelling at her. It was only verbal and not physical at any point.
- 2016-8577 06-20-16 Patron stated he was in Goldiggers and placed items on the table behind him. Items were stolen.
- 2016-8807 06-24-16 Bartender reported dancer complained another dancer stole her money. Dancer then then stole the bartender tips
- 2016-9045 06-27-16 dispatched to 924 Washington St., Gold Diggers, for a Disorderly Conduct call. Officer was told Subject 1 came downstairs and started talking crap to Subject 2. Subject 1 responded back to subject 2's comments. Subject 2 grabbed Subject 1's phone and threw it across the bar. The phone was undamaged. Subject 2 then tipped a customer's drink over and walked away. Subject 2 issued citation for DC.
- 2016-9214 07-01-16 dispatched to Goldiggers at 924 Washington St. for a Disorderly Conduct Call. Dispatch informed us that the bar manager was calling stating she was assaulted by a dancer and that the suspect was still on scene. Dancer stated she asked manager to kick subject out, manager wouldn't, dancer decided to get stuff and leave. Manager got into dancer's face and they began pushing back and forth. Manager began swinging and dancer did admit to hitting manager with a closed fist one time. Both issued citations for DC
- 2016-10562 07-23-16 responded to GOLDIGGERS, 924 Washington Street, for a theft complaint. Patron went to bathroom and when returned noticed his wallet was missing.
- 2016-10825 07-27-16 While handling another call officer was informed of prostitution occurring. Employee was going to watch surveillance from previous complaint and dancer expressed concerns about which video officer would be seeing and the dancer told employee she that she had been "fucking him in the VIP room."

2016-10962 07-30-16 when I got waved down by one of the bartenders at Goldiggers. The bartender pointed to the side of the building. When I pulled in the parking lot, I noticed a male passed out along the east wall of Goldiggers. The bartender stated the male, who was later identified as WILLIAM SIMMS, was inside Goldiggers but then left and people were concerned for his well-being after he passed out along the outer wall of Goldiggers.

2016-12505 07-30-16 dispatched to Goldigger's, 924 Washington Street, for a report of someone being struck in the head with a bottle. Dancer 1 was involved verbal argument with dancer 2. Dancer 2 struck dancer 1 in the face with an object. Officer watched video surveillance and observed the verbal/physical fight between dancers with both striking each other. Dancer 1 charged with battery. Dancer 1 placed bag with money down and dancer 3 stole money. Dancer 3 charged with theft.

2016-16777 11-11-16 responded to Holy Family Memorial Medical Center (HFMMC) for the report of an assault that had occurred at GOLDIGGERS, 924 Washington Street, around 0230 hours. Subject 1 was approached by subject 2 who starting punching subject 1. Bartender stated subject 2 has been causing issues for subject 1. Subject 2 was tackled by friends after attempting to attack subject 1. Subject 2 said her leg was broken. Subject 2 stated that she was "body slammed" by her boss at GOLDIGGERS. In the video, it shows subject 2 jumping off of the stage and staying on the ground for approximately 15 seconds, before the bouncer assisted her up and sat her at a table. Once subject 2 got up from the table, she was moving her leg as if she was in pain. This was before DEAN allegedly body slammed her and threw her out of the establishment

2016-17129 11-18-16 responded to the area of GOLDIGGERS, 924 Washington Street, for the report of a fight in progress. The caller stated that subject 1 was on scene, and causing issues with the bouncer and bartender. Subject 1 is the ex-girlfriend of the bouncer.

- 2017-324 01-08-17 Caller stating there are about 20 subjects at Goldiggers were about to fight. Utl
- 2017-2158 02-16-17 Dispatched to GOLDDIGGERS, 924 Washington Street in regards to a fight in progress. Arrived on scene and observed two parties yelling at each other outside the bar. Subject charged with Bail jumping
- 2017-5538 04-23-17 Complaint was dancer at Goldiggers. Complainant was assaulted and items searched through by another dancer. Other dancer was charged with Simple Battery and Robbery w/use of force.
- 2017-5672 04-26-17 Employees at Goldiggers were harassing employee while she was at work at Subway, 1011 S 10th St. Upon arrival at the scene, I spoke to subject who stated the following; while she was working at Subway, two employees from Goldiggers went into the restaurant and ordered some food. One employee asked subject to work at Goldiggers. Since that night, employees at Goldiggers have called Subway several times, asking for her. Subject wanted Goldiggers employees told not to have contact with her. I spoke to the manager at Goldiggers and explained the incident to her.
- 2017-7554 06-01-17 Complaint not using liquor distributor- Bar manager denied this and had receipts
- 2017-8373 06-15-17 Complainant was dancer. Stated she had tip money taken by customer and given to other dancer and dancer brought it up once told to not worry about it. Manager Hayes and girlfriend and dancer had argument as Exoticas was unwilling to pay dancer now. Dancer stated possible prostitution occurring due to "Hayes" telling subject1 that she would make more money if she worked with "Hayes". Subject1 stated that she interpreted this as meaning that "Hayes" would be her pimp.
- 2017-10517 07-17-17 Subject stated that she has filed a harassment complaint in the past in reference to a female who continues to call subject at her place of employment (Subway) subject suspects the calls are from a white female exotic dancer known as Rose who works at Club Exotica, 924 Washington Street
- 2017-10709 07-21-17 Complainant stated he was approached by patron in bar stating "do you want a kiss". Complainant left and was confronted in parking lot by male and stated he was struck by subjects.
- 2017-10940 07-24-17 Subway owner stated his complaint of trespassing would be the result of the culmination of incidents which have occurred recently involving Club Exotica employees. Subway owner stated he feels that due to the young age of his employees that he wanted to formally advise the owner of Club Exotica that his employees are no longer welcome at the Subway at 1101 S. 10th Street.
- 2017-12793 08-23-17 Manager waved down police. Manager and witness said patron and dancer were engaging in sexual activity in VIP room and were kicked out. Patron stated manager barged into

room and demanded more money for no reason and manager was trying to fight him and calling him racial slurs as he was being removed. Patron was making racial slurs to about manager per witness.

2014-14209 09-18-17 Family trouble between Tina Pirtle and Zacchues Hayes in bar. No charges.

2017-14534 09-24-17 Subject robbed of money at Econo Lodge by two female dancers of Exoticas that he invited by to his motel room for sex.

2017-15339 10-08-17 Subject reported being robbed by two black males as was walking female dancer from Exotica's home. Dancer was charged with Party to the Crime of Armed Robbery

2017-16075 10-22-17 Officer Kirchner observed a large crowd outside the door of Exoticas. While I was approaching, I saw a male raise his hand and bring it down. I then heard glass break and saw the male run through the crowd and down the street. Subject issued DC citation

2017-16644 11-01-17 Detective Kowalski's intelligence report regarding Human Sex Trafficking at Exotica's Strip Club 924 Washington St, Manitowoc. The owner of Exotica's, ZACCHUES HAYES has also been identified through reliable sources as an alleged PIMP using force, fraud and coercion against the females that work at the club.

2017-18762 12-12-17 The informant stated subject1 had begun a relationship with a female who was employed through Exotica's Club located at 924 Washington St, Manitowoc. The informant was concerned because they were told subject 1 was recently robbed by this individual that he sent photos of. I also learned there was an exchange of money between the two for sexual experiences. Rogers charged with Prostitution and Theft

2017-18996 12-17-17 Bouncer and dancer took caller for \$40.00 and kicked him out subject very intoxicated went into women's dressing area and refused to leave, then was kicked out by bouncers. He was told the \$40 was a civil issue, and he was given the owner's business card to take any property issues up with the owner in the morning. RP told if he would go back he would be cited and or arrested.

- 2018-1664 02-03-18 Complainant was bar. Dancer was disorderly and struck bartender. Dancer charged with DC, Obstructing, Resisting
- 2018-3031 03-03-18 Complainant was bar. Female party attempted to steal money from dancer's tip jar. Subject trespassed
- 2018-7205 05-26-18 Fight in bar. No charges filed and no patrons admitted to observing the altercation
- 2018-7206 05-26-18 AOLEA in parking lot for warrant and probation/parole violation for being intoxicated.
- 2018-8843 06-23-18 I issued a citation for Prostitution, 14.240(1)(c) because dancer admitted that she was "fingered by the man" and received money for it. Came in as a DC complaint with dancer as complainant for being pushed out of bar. Bartender saw sexual contact and had subject removed.

- 2018-17290 11-24-18 Remove intoxicated patron from bar
- 2018-18411 12-18-18 Dancer arrested for prostitution at different locations. Based on the statements that both suspects made regarding possible entertainer license violations at Exotica's the Club as well as prostitution acts that originated in the club through the date being set with the undercover operation occurring inside Exotica's that follow up with the club needed to take place.

2019-236 01-04-19 Subject informed me there was an altercation between a few customers and one of the entertainers. While attempting to speak to the entertainer (subject 1), another entertainer, subject 2 began arguing with subject 1. The argument between subject 1 and 2 was from an altercation that happened between two males and a female, who were customers and wishing to take one of the entertainers home with them. Subject 1 was attempting to stop this from happening, which upset the customers and words were exchanged. The customers had left on their own prior to police arriving.

2019-6488 05-11-19 disturbance broke out inside of the bar when a female allegedly bumped into another male, and then the male called the female a bitch. She said the girl's boyfriend allegedly took issue with the comment and a fight broke out inside of the bar. I watched on camera at approximately 0200 hours where there was an argument near the stage. A black male with dreads in an unknown sports team jacket pushed into a crowd that included a white female. Subject 1 said the white female in the video was the female who accidentally pushed the male. The suspect in the sports jacket tried to fight the white female and subject 1 identified male subject as one of the parties in the crowd who tried to break up the fight. The suspect in the sports jacket and another male were on the front entrance camera clearly upset and shown out of the bar. We switched to the outside camera and at 0205 hrs., a group of people could be seen on the surveillance footage outside of the bar, but we were unable to see the disturbance across the street on the south side of the road in the Subway parking lot. We saw the suspect vehicle noted above parked in the 900 block of Washington Street in view, and at 0205 hrs., the vehicle doors opened on the car. It 0206 hrs. a flash was seen from the passenger side door consistent with a muzzle blast from a handgun. There were still people present in the area when the muzzle blast was seen on camera

2019-9696 07-07-19 I, Lt. Erickson, observed that EXOTICAS THE CLUB was open for business, which is in violation of WI S.S. 125.32(3)(a), adopted as City Ordinance 11.010 (1)(a). The front door was being held open with a bar stool, the outdoor and interior lights were on, and music was playing loudly with bass that could be heard from a block away. Citation for Tavern Open After Hours issued to Exotica's

2019-10107 07-13-19 Fight inside Exotica's. EXOTICA'S security members said that patron pepper sprayed one of the employees.

2019-10109 07-14-19 UPON ARRIVAL MULTIPLE WITNESSES STATED THAT NO FIGHT HAD TAKEN PLACE. WITNESSES STATED THAT CLUB PATRONS HAD BEEN DANCING AND ENGAGING IN POSSIBLE HORSEPLAY OUTSIDE OF THE CLUB. NO EVIDENCE THAT A FIGHT HAD TAKEN PLACE WAS OBSERVED. NO REPORT NEEDED AT THIS TIME.

2019-11397 08-04-19 Bar called for DC complaint. Bar had told subject not to come back due to prior incident. Subject returned to bar. Subject got angry and left the bar. Subject then came back into the bar to find the group of people that she was with. Subject again left the bar and came back in a second time. On her way out, subject flipped over a bar stool and threw a fan that was by the entrance. Subject also threw a bar stool outside into the road. Bar stated subject broke the fan. Subject issued citation for DC and warning for trespass

2019-11769 08-11-19 several other officers were dispatched to Exotica's, 924 Washington Street, for a report of a physical fight that was occurring at the location. At the time of the call, officer was about two blocks away. When officer arrived, there was a large group of individuals outside of the establishment yelling. When officer exited my patrol vehicle, most of the individuals left the scene on foot. Subject issued citation for DC

2019-14579 09-29-19 Subjects had contact at bar as subjects had run into bar and officers could hear owner yelling. Subjects escorted from bar by owner. As officers were dealing with this officers observed disturbance from the crowd, which was still standing on the sidewalk, directly in front of EXOTICAS. One male, took his shirt off and began screaming. He was yelling numerous profanities, including "Fuck you!" to an unidentified person. Subject issued citation for DC and resisting. Officer explained to employee the importance of "bar time" and how to get the patrons escorted off of the premises earlier than exactly 2:30am. Officer told her having another security guard to escort everyone out at 2:10-2:15 would help, which she agreed with. The employee was notified that if her establishment was open later than 2:30am in the future, even one minute, she would be receiving a citation

2019-14906 10-05-19 Officer attempting to contact subject who entered Exoticas that has probation rules. Officers were met with a verbally abusive crowd that was yelling "fuck the police" and various other vulgar statements.

2019-15341 10-13-19 Exotica employee contacted officers due to patron disturbing customers and harassing other patrons inside of Exotica's.

2019-16074 10-26-19 I, Lt. Sohlden, was parked in the parking lot on the SE corner of S 10th St and Washington St, monitoring the area of EXOTICA'S, located at 924 Washington St. I observed two subjects, later identified as Subject 1 and subject 2 exit the front (south) entrance of EXOTICA'S. I was able to hear subject 1 and subject 2 yelling at each other to a volume which I could clearly hear at my location (approximately 100 feet away). Off. Gardner later advised that the male subject was subject 3, from past law enforcement contacts. Subject 3 said that he could handle the situation and that everything was okay. I advised him that I was investigating the disturbance as it was occurring in a public place, not inside of EXOTICA'S. Subject 3 said "fuck you" to me several times as he did not like that I was investigating a disturbance where what he explained and thought was his responsibility

2019-16477 11-03-19 the manager of Exotica's had requested subject to leave the club because she was intoxicated and causing a disturbance. Bar asked subject to leave the club due to her starting to swear and raise her voice. When subject would not cooperate, bartender started to push subject out of the club.

2019-17202 11-17-19 As Officers were parked across the street we observed a large crowd exit Exoticas. Once the crowd exited, we heard loud yelling and saw people shoving each other. As Officers were trying to control the situation, numerous cars full of people left the scene. Officers stood by in a peace Officer capacity until the crowd was fully dispersed. Based on nobody being able to specifically identify who was involved in the physical altercation no citations or charges were issued.

2019-17886 11-30-19 Dispatch advised two subjects were attempting to enter Exoticas to fight with people. I spoke with bar employee who stated that subjects had attempted to enter Exoticas, but he

advised them they were not welcomed. This upset them and they began yelling at him. Bar employee stated nothing became physical and that he did not want press charges

2020

2020-216 01-05-20 Theft of wallet from subject inside bar. I then contacted the management for the Exoticas Night Club (924 Washington Street), who informed me they were unable to recover any video surveillance of the theft because the surveillance system resets every week on Saturday night. The management for the Exoticas night club then added they did not have any suspects or further leads concerning the wallet theft. Due to the lack of cooperation by the management for the Exoticas Night Club and lack of any other evidence, I am not able to further investigate the theft.

2020-1810 02-07-20 Complaint that dancers was having sex in back bathroom and serving minors. Bar checked no sexual activity observed, no underage observed in establishment

2020-2178 02-15-20 Bar called as two subjects were outside wrestling/fighting. Bar didn't want anything done. Subjects told not to come back

2020-6215 05-17-20 , Officer Tuma, along with Officer Klein, was dispatched to 924 Washington St., EXOTICAS, for a report of a male party kicking a door in at that location. Officer Klein remained with the subject while I spoke with the caller. Caller informed me while the subject was inside the business; he started to yell at her and said he was going to "kick her ass." Caller stated she was tired of the subject's behavior and she wanted him gone. I asked if the caller feared for her safety, which she replied "No, but he's drunk and I don't know what he's going to do. The caller stated there was an employee who was at the business and left because she felt uncomfortable from the subject's yelling. Subject cited for DC

2020-6865 05-29-20 Complaint that dancers needs to be removed. Subject removed without incident.

2020-7114 06-04-20 Bar called for fight. Fight ended prior to officers' arrival

2020-7671 06-14-20 Officer was exiting my patrol car at the PD, when I heard yelling coming from the parking lot next to EXOTICAS, located at 924 Washington Street. From my location I was unsure of what was occurring so I walked over to the parking lot and observed two fights in progress. It appeared there were approximately 20 individuals and I observed grappling occurring at two locations in the parking lot. Another subject also reported gun stolen from vehicle parked in the parking lot.

2020-8023 06-20-20 I saw there was a large group of people outside of Exotica's and they were shoving and throwing punches at each other. I also heard yelling and screaming that came from this location. I drove up to the front of the bar and I saw there were at least 20 people pushing and punching at each other. I turned my lights and siren on in my squad and I called out for other additional units to assist. I blipped my siren several times to get the fight to break up. The group in front of the bar saw and heard my squad and quickly dispersed; however, there were still a group of people that remained and they were heated and argumentative. The other group was both patrons and the owners of Exotica's. Officers identified the manager of Exotica's, her son, and her husband and co-manager,. Caller was very upset and confrontational with the group from Milwaukee. Caller alleged a member on this bus punched a female inside the bar. Caller said this female was one of her dancers and she wanted to confront a male on the bus. People had to restrain caller and one of her employees had to bring her back inside the bar. I saw co-manager was also heated with another individual that was on this party bus.

2020-11985 08-26-20- Fight breaking out. No longer fighting and everyone left prior to officer arrival.

2020-12177 08-29-20 Dispatch advised, the caller previously fought with a group of females at a bar. The group of females was outside the above address. It was reported that a large group of people were actively fighting in the middle of Philippen St. Subject 1 indicated that this incident started at Exotica's (924 Washington St.) approximately thirty minutes ago. Subject 1 was with subject 2, parked in front of Exotica's when caller approached the vehicle, started arguing with subject 2 and at some point, caller slapped subject 2 in the face. Subject 2 and Subject 1 exited the vehicle, and both, caller and subject 2, continued to argue, resulting in a physical altercation. JASMINE indicated she exited Exotica's at approximately 0400 hours. Caller was walking towards her vehicle when she was approached by subject 2. Caller and subject 2 started arguing, which resulted in subject 2 slapping caller in the face. Caller stated she then punched subject 2 several times. I responded to Exotica's and made contact with the manager regarding this incident. Manager indicated that she saw the caller and subject 2 having an argument earlier in the night. Manager stated subject 2 was highly intoxicated, so she helped her to subject 1's vehicle. At approximately 0300 hours, manager thought subject 2 went home, until she came back to the bar. Manager stated subject 2 was sitting outside with subject 1. Caller was still inside Exotica's, waiting for subject 3. Manager told caller that subject 2 was waiting outside. Caller and subject 3 did not want any further trouble, so they waited inside. Subject 1, Subject 2, Caller, and subject 3 charged with DC.

2020-12237 08-30-20 When subject 1 arrived at Exotica's, he walked into the front door. The manager, or what he believed to be the manager, immediately punched subject 1 in the face and kicked him out of the bar. I asked subject 1 if he did anything that deserved getting hit. Subject 1 stated he did nothing, but walk into Exotica's. I called subject 2 back and she informed me that she told subject 1 to not come to Manitowoc. Subject 2 stated that when subject 1 entered Exotica's, he got into an altercation with another patron. When subject 1 and the other patron were outside, the doors to Exotica's were locked. Subject 2 did not see subject 1 get hit.

2020-12628 09-06-20 Employee called due to disturbance between patrons

2020-14139 10-06-20 2 Dancers refusing to leave, being disrespectful. Caller stated that two dancers, were refusing to pay a \$10 fee. This resulted in a verbal argument. Dancers were being rude to caller. Caller asked them to leave and they refused so she called the police. I spoke with the dancers who confirmed that they were upset about the fee and did not think they should leave. Both subjects were removed from the bar without incident. Caller stated that she did not want any charges for dc or trespassing just wanted them removed.

2020-15993 11-15-20 Three dancers being served by bartender. No violation. Managers showed officers system of vetting to make sure underage dancers only received water (or juice on some occasions). Complaint unfounded

2021

2021-2207 02-22-21 I, Officer Hansen, and Officer Thiel were dispatched to Exoticas, 924 Washington St., to check the welfare of a male that was reported to be passed out in the bathroom. EMS later advised me that subject was diabetic and had taken heroin.

2015-2694 03-06-21 People screaming and hollering. Subjects removed from bar per request of bartender

2021-3597 03-27-21 I heard yelling coming the front entrance area of EXOTICA'S, 924 Washington Street. I radioed the information to dispatch and I turned east onto Washington Street. When I got in front of EXOTICA'S, I saw a few people standing in the doorway yelling at each other. I saw approximately four to six people yelling at each other, and grappling with each other as they appeared to be pushing each other outside. The group of people moved east along the building wall as they continued to yell, push, and pull each other. I was able to see that subject 1 was punching a male. Employee said she knew that the male subject was subject 1's significant other. Employee said that subject 1 was an employee at Exotica's. Charge of DC-DVO on male subject

2021-5235 05-01-21 I, Officer Place, along with multiple other officers from the Manitowoc Police Department and MTSO responded to Exotica's, 924 Washington St., for a large fight that took place inside the bar. Dispatch advised they received multiple 911 calls of a physical fight in progress at that location and there were injuries

2021-5332 05-02-21 Dispatch advised that the club manager was calling in regards to her son, being on the property. Manager stated that her son has given vague threats towards her and subject 1 which she believed involved using a gun. Manager did not wish to make statements about the threats, but just wanted her son and subject 2 to be trespassed from the property. Manager stated that her son has been using illegal narcotics which is causing him to act the way he was.

2021-12981 09-24-21 the PD received a Human Trafficking Tip from P3 regarding a Milwaukee student, who is 18 YOA. She was reported to possibly being sex trafficked by her boyfriend who was identified as "TAUNTO" Detective Kowalski, learned student had reached out to our officers regarding this complaint and the welfare check. Student made contact with officers via the telephone and confirmed her current address of 2004 28th St, upper apartment, Two Rivers and denied any allegations of sex trafficking. Student also stated that she was safe and was currently in the City of Manitowoc for work/employment purposes only.

2021-13036 09-26-21 Lieutenant Erickson informed me that some subjects appeared to still be exiting EXOTICAS after bar close. I responded to EXOTICAS and discovered that the door was locked. The "OPEN" sign was still lit up, and we could hear numerous people talking inside the building. 20 YOA in bar with 18 YOA girlfriend who is dancer. Bar and subject cited for loitering in tavern and permit to loiter in tavern. Because subject 1 seemed fearful while she was in the bar and subject 2 was yelling at her, I later called subject 1 to follow up with her. I asked subject 1 if she felt safe working at EXOTICAS, and she stated she did until tonight, but now she did not. Subject 1 said after officers left, subject 2 yelled at her and asked why she did not lie for subject 2. Subject 1 told me that subject 2 threatened her, saying if EXOTICAS got shut down because of subject 1, subject 2 would, "Beat my ass."

2022

2022-276 01-07-22 Physical altercation with dancers at club. Subject 1 stated 3 other dancers were pushing and shoving her and that they were breaking "stripper etiquette. Bartender, and another unidentified dancer advised that all aggressive parties had been kicked out of the bar and had left prior to officer arrival. Bartender stated the dancer with braids subject 1 was the cause of the drama at the club and began pushing and shoving other dancers

2022-959 01-23-22 Subject 1 was upset with subject 2 about being fired and was yelling and it sounded like she was damaging things in the lounge area there was no physical altercation, and no property damage other than the cut cable. Subject 2 left peacefully and there is no further need for follow-up.

2022-962 01-23-22 Subject 1 was informed of how to obtain a restraining order, and informed subject 2 being parked across the street was not illegal. I told Subject 1 to call if Subject 2 shows up at the business and starts causing issues.

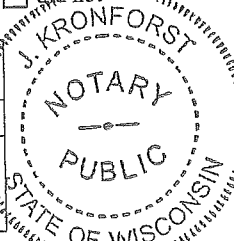

I believe the arrested person committed this offense(s) because: (summarize below)

On Friday, 03/03/2023 at 0306 hours, I, Officer A. Scopp, conducted a traffic stop on a black, 2005 Infiniti FX35, bearing WI RP #APX-5542, due to an inoperable driver-side headlamp. Upon making contact with the operator of the vehicle, MICHAEL RAY, I smelled the aroma of marijuana emanating from the vehicle. After serving MICHAEL his traffic citation, I asked him to step out of the vehicle; he complied. I explained to MICHAEL the reason why I had him step out of the vehicle, at which time I asked him for consent to search his vehicle; MICHAEL gave consent.

Officer Wilker and Officer Draxler arrived a short time later, then searched the vehicle. While officers were searching the vehicle, MICHAEL stated the only thing that belonged to him in the vehicle was the backpack full of cash (American currency) sitting on the front passenger seat. MICHAEL stated he had the large amount of money because he's the owner of Exotica The Club, an adult entertainment establishment in Manitowoc.

Officer Wilker advised me that he located a green, leafy substance between the front passenger seat and center console, consistent with that of marijuana. Officer Wilker stated he also located a blue, sealed package containing what he believed to be THC, due to the labeling. The blue, sealed packaging was located in the backpack on the passenger seat which MICHAEL stated was his.

I later transported the evidence to the City of Manitowoc Police Department, where Officer Wilker tested it. Officer Wilker advised me that the green, leafy substance he located between the front passenger seat and center console, weighed 0.9 grams, and tested positive for the presence of THC using a Duquenois-Levine Reagent test. Officer Wilker also advised me that the blue, sealed packaging also contained a green, leafy substance, which he then tested using a Duquenois-Levine Reagent test. The substance weighed 2.6 grams, and tested positive for the presence of THC. The overall weight of THC was 3.5 grams. See Officer Wilker's addition for further information regarding the testing, as well as packaging and logging of evidence.

I advised MICHAEL he was under arrest for possession of THC, at which time MICHAEL turned away from me and placed his hands behind his back. Officer Wilker handcuffed MICHAEL, then searched him incident to

arrest; no contraband was located. I escorted MICHAEL to my patrol car where I placed him in the back seat. Officer Wilker secured MICHAEL's safety belt.

I transported MICHAEL to the City of Manitowoc Police Department where I obtained MICHAEL's fingerprints and mugshots. MICHAEL was cooperative throughout the process. I later transported MICHAEL to the Manitowoc County Jail, where custody was transferred to correctional staff.

I completed a hold sheet. I completed a digital evidence slip.

I'm referring the following charges for MICHAEL RAY;

POSSESSION OF THC (FELONY) – WI SS: 961.41(3G)(E) for the following reasons;

- MICHAEL was found in possession of a total of 3.5 grams of THC.
- Officer Wilker tested a representative sample of the green, leafy substances individually; the tests produced a positive indication for the presence of THC.
- This is a felony due to a prior 2007 conviction for possession w/intent (cocaine). Reference Fond du Lac County Case #2007CF000279.

BAIL JUMPING (FELONY) – WI SS: 946.49(1)(B) for the following reasons;
