<sup>\*</sup>The Room Tax Commission met on November 4th just prior to the Mayor's presentation and approved a budget for Room Tax SRF (Fund 2130) that included a transfer of \$5,000 to the MIRA SRF. The original estimate of \$400 needed to be revised. Revisions to Fund 2130 and Fund 2131 have on impact on the City's overall tax levy.

At the November 19, 2025 Finance Committee Meeting, it was moved by Alderperson Schlei, seconded by Alderperson Brey, to approve the 2026 Budget as presented and forward to Council for consideration. This motion carried 5 - 0. Revisions to the Assessed Value and Assessed Tax Rate based on receiving the final equated manufacturing values from the WDOR, and to Funds 2130 and Fund 2131 revenue and expenses were included in the presentation. The 2026 budgeted revenues and expenses detailed in agenda item #25-1957, under attachment labeled "2026 Finance Committee Recommended", are being recommended for consideration.
