Dan,

I'm pleased to inform you that the City of Manitowoc SISP application for funding was approved. The project will be funded 90% State /10% Local. As shown in the State Municipal Financial Agreement (see attached), the 90% State portion of the project is capped, so any amount over the maximum will need to be funded by the city. The City is required to pay for all services (design and construction) up front and then request for reimbursement from WisDOT after you have paid those respective bills. The City can enter into a design contract with a Consultant at any time, but reimbursement for those services cannot be requested from the State until July 2028 at the earliest. Once WisDOT receives the reimbursement request (just a simple form with a copy of the check), we will submit it to Madison from processing which takes roughly 1-2 month.

Also, the City can contract with any contractor you wish to. If you choose to utilize WisDOT's Electrical Services Contractor, you are still required to enter into a contract with them. This project is required to be designed and paid in full by December 1, 2029 and constructed by December 1, 2030. Any reimbursement requests submitted to WisDOT after that date will be denied.

Please note your original application requested funding for design in FY2026 and construction in FY2027. Due to the program funding availability your project was approved for FY2028 Design and FY2029 construction.
