Ald. Czekala,

We are planning to send the attached revised State/Municipal Financial Agreement (SMFA) for the SISP Traffic Signal project at the intersection of S. 21<sup>st</sup> and Washington St. to the Common Council meeting on August 21<sup>st</sup>.

The DOT's contract with Bodart Electric Service expired at the end of 2022 for the SISP work. The DOT received new prices and Elmstar was the contractor that the DOT has selected to use for the next round of SISP projects.

However, Elmstar's prices were significantly higher than the previous contractor, so the DOT allowed municipalities to submit a revised cost estimate for the work. They have approved the higher costs and have put the higher amounts into the revised SMFA.

I have also attached the original e-mail dated 1/6/2023 from the DOT on this issue.

I have also attached the original SMFA.

The original SMFA had the State Funding Limit for construction at \$251,100 and the new State Funding Limit is at \$295,200, so an increase of \$44,100.

We are requesting that you approve this revised SMA from the DOT at the next Council meeting without going to the PI Committee first. Thanks.
