

**RESOLUTION AUTHORIZING A  
HARBOR ASSISTANCE PROGRAM (HAP) GRANT APPLICATION**

**WHEREAS**, the City of Manitowoc submitted their Harbor Assistance Program grant application pursuing crane platform extension in Manitowoc, Wisconsin. The project consists of a 140-foot crane platform and loadout ramp to allow construction of multiple gantry cranes and loading them on to barges for shipment to customers; and

**WHEREAS**, the City of Manitowoc agrees to assume all grant responsibility; and

**WHEREAS**, in fulfillment of the Manitowoc Harbor plan to maintain commercial port operations; and

**WHEREAS**, in order to obtain funding for the above-described projects, a grant application will be filed as an application with the Bureau of Railroads and Harbors and Wisconsin Department of Transportation (WisDOT), through the Harbor Assistance Program. The estimated total construction cost is \$3,143,175. It is intended that the grant application will be in the amount of \$ 2,514,540 with a matching share of 20% in the amount of \$628,635 being paid by City Centre, LLC; and

**WHEREAS**, City Centre, LLC will maintain ownership of the loadout facility property adjacent to the area.

**NOW, THEREFORE, BE IT RESOLVED** that the City of Manitowoc hereby requests a grant amount of \$2,514,540 from the Wisconsin Harbor Assistance Program for the project identified as the Crane Loadout Facility.

**BE IT FURTHER RESOLVED** that Mayor Justin Nickels is authorized to sign agreements, forms, claims, and other required documents binding the City of Manitowoc in conjunction with the application for Wisconsin Harbor Assistance Program funds.

**BE IT FURTHER RESOLVED** that City of Manitowoc hereby agrees to provide to WisDOT in a timely manner, additional analysis, or documentation in support of the application, if necessary, for the review process.

**BE IT FURTHER RESOLVED** that the City of Manitowoc will enter into an agreement with City Centre, LLC to provide such amounts of matching funds as may be required up to a maximum amount of \$628,635 upon the signing of a grant agreement in a time and manner specified by WisDOT.
