

ORDINANCE

An Ordinance to amend Section 10.170 of the Manitowoc Municipal Code regulating Through Intersections.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1. Section 10.170 is amended to read as follows:

“10.170 Through Intersections.

...

South 11th Street.

(a) All traffic on South 11th Street shall stop before entering Columbus Street.

(b) All traffic on South 11th Street shall stop before entering Madison Street.

...

South 13th Street.

(a) All traffic on South 13th Street shall stop before entering Division Street.

(b) All traffic on South 13th Street shall stop before entering Columbus Street.

(c) All traffic on South 13th Street shall stop before entering Madison Street.

South 15th Street.

...

(c) All traffic on South 15th St. shall stop before entering Madison Street.

...

South 17th Street.

(a) All traffic on South 17th Street shall stop before entering Columbus Street.

(b) South 17th Street. All traffic on South 17th Street shall stop before entering Madison Street.

...

Columbus Street.

...

(e) All traffic on Columbus Street shall stop before entering South 12th Street.

...

Grand Avenue.

...

(f) All traffic on Grand Avenue shall stop before entering South 12th Street.

...

Green Street. All traffic on Green Street shall stop before entering South 12th Street.

...

Madison Street.

(a) All traffic eastbound and westbound on Madison Street shall stop before entering South 16th Street.

(b) All traffic on Madison Street shall stop before entering South 12th Street.

(c) All traffic on Madison Street shall stop before entering South 18th Street.

...

Manila Street.

(a) All traffic entering South 16th Street from Manila Street shall stop before entering South 16th Street.

(b) All traffic on Manila Street shall stop before entering South 12th Street.

Philippen Street.

(a) All traffic entering South 16th Street at Philippen Street shall stop before entering South 16th Street.

(b) All traffic on Philippen Street shall stop before entering South 12th St.

...

Wisconsin Avenue. All traffic on Wisconsin Avenue shall stop before entering North 14th Street.

...”

Section 2. This ordinance shall take effect the day after publication.

Fiscal Impact:	Ordinance to amend 10.170 will require an additional 30 new stop signs and posts. Anticipate a cost of \$250 for each post and sign; therefore, fiscal impact of \$7,500 for the additional 30 stop signs to have the amendments to through intersections detailed above occur. In addition, approximately \$500 in expenses for code updating, publishing and noticing. Total fiscal impact of this ordinance anticipated \$8,000. No additional tax levy or budget amendments needed.
