Hi Joe,

I think that we are looking to bring this issue back to the PI Committee at their next meeting which is scheduled for Wednesday, August 2<sup>nd</sup> at 5:30 pm at City Hall.

We have included a budget item in the 2024 budget for relining this storm sewer pipe.

Hopefully, this will be approved for inclusion into the 2024 budget.

I think most of us agree that it would be best to get the sewer relocated, so that it is not under the garage and/or house. However, that said, I believe that installing a new storm sewer across your back yard into the low area to the northeast of your home will likely cost much more than the relining, so I am not sure that they will support that or they will say wait until we budget for the upsized storm sewer per the 2022 Flood Study Report that Strand prepared. I have no idea how soon they will think about doing that upsizing of the storm sewer from the Little Manitowoc River up to N. 5<sup>th</sup> and Pine.

Therefore, I thought our best option is to just get the pipe relined ASAP to make sure that we do not have any soil migrating into the existing pipe that could cause a foundation to settle.

We certainly appreciate your willingness to contribute towards the project and that you are willing to grant an easement for a new pipe location if they decide to go that route.

I do not have any knowledge about any state discretionary funding for a situation like this.
