This federal grant includes a cost match component: 75% is covered by the federal funding, while the City is responsible for the remaining 25%. Given this 25% cost share, Chief Blaser seeks your approval to pursue this grant opportunity.

The Baby Box serves as a safety device for newborns, featuring an automatic locking door that secures the baby once placed inside. There is an interior door that allows medical staff to retrieve the surrendered baby from within the designated building safely.

The proposed location for the Baby Box is at Manitowoc Fire Rescue Station 3, located at 3820 Dewey Street. Funding for this initiative will be sourced from grants and fundraising efforts organized by the Manitowoc County Safe Haven Baby Boxes Initiatives Committee.
