There should be a curve sign for northbound traffic. The same as the one we have for southbound traffic.

We could also possibly paint a yellow centerline around the curve as well.

No one really likes guardrail in front of their property, but if nothing else works, then the guardrail option might have to be used.

Subject: North 9th St. Between Huron St. and New York Ave. - Complaint about Property Damage to Fence at 823 N. 9th St.

Hi Nick,

Phillip Strazny (920-973-1932) stopped in the Building Inspection Dept. and the Engineering Dept. informing us that his fence has been hit twice in the past 3 weeks and a third time earlier this year.

Do you have accident reports for all of this incidents and/or how many other incidents has there been up there. He claimed there was another one on the west side of the street or they hit a pole or something.

He was inquiring if there is anything the City can do to help this situation.

He stated that it is likely impaired drivers using N. 9th St. and then they do not negotiate the curve north of Huron St.

I told him that perhaps more enforcement during the late night or early morning hours may help.

If they are impaired drivers, any additional signage will probably not matter.

I told Phillip I would contact you and see if enforcement is an option or if the issue should be brought to the Public Safety Committee, so that there is a better record of the complaint.

He threw out the idea of a cul-de-sac for N. 9th St. I do not believe that there is any way to realign the street without acquiring several properties.
