

**RESOLUTION UPDATING BOUNDARIES OF THE STREET SNOW
REMOVAL AREA FOR 2025-2026 SNOW SEASON**

WHEREAS, Section 7.24 of the Manitowoc Municipal Code provides that assessments for street snow removal may be assessed by Resolution of the Common Council; and

WHEREAS, Wisconsin Statute §66.0627 authorizes municipalities to impose a special charge against real property for current services rendered by allocating all or part of the cost of the service to the property served; and

WHEREAS, non-residential property on both sides of the following streets shall be assessed:

1. 8th Street from Marshall Street to Park Street
2. 10th Street from Madison Street to Park Street
3. North 9th Street from Maritime Drive to Chicago Street
4. Buffalo Street from North 7th Street to ~~North 11th Street~~ **River Point Drive**
5. Chicago Street from North 7th Street to North 10th Street
6. Maritime Drive from North 6th Street to North 10th Street
7. York Street from North 7th Street to River Point Drive
8. South 6th Street from Jay Street to Quay Street
9. South 7th Street from Washington Street to Franklin Street
10. South 9th Street from Quay Street to Marshall Street
11. South 12th Street from Franklin Street to South Water Street
12. South 26th Street from Washington Street to Marshall Street
13. Calumet Avenue from South 25th Street to South 41st Street
14. Custer Street from the 2700 Block to Calumet Avenue (south side)
15. Franklin Street from South 6th Street to South 14th Street
16. Jay Street from South 6th Street to South 10th Street
17. Marshall Street from South 26th Street to Calumet Avenue
18. Quay Street from South 6th Street to South 10th Street
19. Washington Street from South 7th Street to South 26th Street
20. North 11th Street from Buffalo Street to York Street
21. River Point Drive from North 10th Street to York Street;

WHEREAS, snow will also be removed in front of any other qualifying business places in the City not located on streets mentioned above, where application is made in writing and accepted by the Director of Public Infrastructure in writing, and the cost of removing such snow against their property will be set by action of the Public Infrastructure Committee.

NOW THEREFORE BE IT RESOLVED, by the Mayor and Common Council of the City of Manitowoc, that all non-residential property abutting the above-listed streets be assessed the sum of \$2.00 per lineal foot per season or any part of a season.

BE IT FURTHER RESOLVED that this Resolution shall take effect commencing with the 2025-2026 snow season.
