Mayor,

Please note that I did not include Mike and Devin Holschbach on this e-mail. It is internal only.

Here are the two estimates that we received.

Much higher than what we thought and talked about internally.

How do we want to proceed with this??

Another option would be to save the curb, but then we have to remove the sidewalk at the driveway (the concrete cutting contractor needs about 3.5 feet of clearance behind the curb), so that the saw cutting contractor could saw off all but about ½ inch of the curb head, then Vinton would replace the approach at a significantly greater slope, but similar to what was there prior to the reconstruction. We have estimated this cost to be about the same as the one Vinton has attached. We would save the \$40K on the curb replacement, but the sawing of the curb head and replacement of the sidewalk will be about \$40K.

We would have to get a firm price from Vinton for this option to know for sure what the cost would be.

We also need to determine if there is Capital Budget money available for this work.

Do we want to discuss this issue more at the next PI Committee Meeting on October 4th and make a decision on what to do if anything?

Hi Mike,

We are working with Vinton and Northeast Asphalt to come up with a solution.

We met yesterday and have discussed a couple options.

- 1. We are trying to determine if there is a way to grind off the top (or high spot) of the curb.
- 2. Saw cut the curb at the flow line (gutter) and remove the existing curb, then remove and replace the driveway approach. This will make the approach much steeper, but should still be much better than what is there now.
- 3. Install another 1-1/2" of asphalt over the entire street (from curb face to curb face).

We are working to get cost estimates for each option.

We are hoping to get a resolution before the end of the construction season.
