Good Afternoon Rick,

I am Assistant Chief of Police Jason Freiboth. I was given your email address as a possible point of contact for a parking issue on S. 18th Street. If you are not the right person, could you please forward this email to the right person?

One of WAF's neighbors at 810 S. 18th Street has an adult son with cerebral palsy. They spoke at last week's Public Safety Committee meeting about the parking issue. I wanted to give WAF a head's up that Fred Schwoerer might be reaching out to discuss possible solutions. Fred's son has severe mobility issues due to CP and he gets picked up in the morning and dropped off in the afternoon Monday – Friday. With the current construction project at WAF, parking around the foundry has become troublesome for some of the bus drivers. Initially, Fred was seeking a designated loading zone in front of his address. The committee does not want to start authorizing loading zones in front of people's homes. The committee decided that we wouldn't take any action at this time and wait and see what the parking looks like at the completion of WAF's remodel.

Everyone realizes that public roads are open for anyone to park a vehicle. However, a suggestion was made to ask WAF to see if their employees that park in front of 810 S. 18th Street might consider parking anywhere but in front of their house so the handicapped son can get dropped off safely. Just wondering if this is something that you could help us with?
