Greg,

It does appear that the City may still be in the running for funding through the 2023 BRIC Grant application for Halvorsen Wet Detention Basin Design. The FEMA BRIC website shows the project status as "identified for further review". This means the application was selected and there is available funding under the applicable subtotals. One thing to note is the Federal Share on the FEMA website is \$85,720 while the grant application asked for \$123,750 of the project total of \$165,000. While the project may be funded, the amount of funding could be less than expected. As you mention below, you could also reapply this year for the 2024 FEMA-BRIC grant seeking the full 75% funding for the Halvorsen Wet Detention Basin. However, given the uncertainty you mention in moving forward with the Halvorsen Wet Detention Basin, perhaps it would make sense to let that play out further and then submit in 2025.

Pivoting to go after a BRIC grant this year ('24/'25) for the Custer Street Wet Detention Basin Design sounds reasonable, especially since the City owns the property. Please let us know if you would like us to proceed with developing the 2024 BRIC application for the Custer Street Wet Detention Basin Design Project. I believe we can perform the work for the grant for about \$13,500. If interested, we would develop a task order for the work and send it your way for review.

Please note that the Custer Street Wet Detention Basin project does not mitigate the flooding at the intersection of Mero Street and 29th Street, and the best location for a pond in that area is the sited location in Halvorsen Park. If this green space goes away, I am not sure there is another viable option to mitigate flooding along 29th Street.
