Greetings!!

I hope that all goes well for your department. I am writing to inquire about a possible location for Tom Drill's hut for our Christmas in July campaign and then thinking forward about the kettle season in November and December. With the changes to the traffic patterns placing his hut at the corner of 8th and Franklin does not lend itself to safety for Tom and traffic. We have thought long and hard about alternatives to that location. Would your department be amenable to our placing of Tom Drill's hut on Quay street? We were thinking of three possibilities. One, on the library side of Quay near to their parking lot entrance (so that people who might want to give could safely pull in to the parking lot to do so. Or Two, the park side of Quay near the drive way to the farmer's market for the same safety reasons. I don't know all of the events which may be going on in that park during the month of July (ideally Tom wants to ring for two weeks 7/10-7/22 or somewhere close to that, we can be flexible on dates). The third option would be closer to 8th street within the Burger Boat park area. You may have other thoughts.

We are open to other locations as well. We want to keep Tom's safety and traffic flow as top priorities while still allowing the public to donate as they are willing. Please let me know if you have any questions and suggestions. We would like to have his hut in place by July 10th. Thank you for your consideration.
