

R E S O L U T I O N

AUTHORIZING THE CORRECTION OF SCRIVENER'S ERRORS IN PREVIOUSLY ADOPTED ORDINANCES AND RESOLUTIONS AS A RESULT OF THE REORGANIZATION OF THE DEPARTMENT OF PUBLIC INFRASTRUCTURE INTO THE DEPARTMENT OF PUBLIC WORKS AND THE PARKS AND RECREATION DEPARTMENT

WHEREAS, the Department of Public Infrastructure has been reorganized into the Department of Public Works and the Park and Recreation Department; and

WHEREAS, numerous ordinances and resolutions refer to the Department of Public Infrastructure and titles of employees therein, but are now clearly intended to refer to the Department of Public Works or the Department of Parks and Recreation and to the titles of employees in those new departments; and

WHEREAS, Manitowoc Municipal Code 24.020 authorizes the City Attorney and City Clerk to make nonsubstantive corrections to ordinances which have been adopted for the purpose of eliminating conflicts and ambiguities without specific action by the Common Council; and

WHEREAS, due to the elimination of the Department of Public Infrastructure and creation of the Department of Public Works and the Parks and Recreation Department, numerous ordinances will need to be corrected to reflect this change; and

WHEREAS, the resulting nonsubstantive discrepancies in the Manitowoc Municipal Code shall be considered scrivener's errors; and

WHEREAS, the City Attorney and City Clerk shall have the authority to correct the resulting scrivener's errors to any and all ordinances where such scrivener's errors are found, including, but not limited to:
