## Public Safety Committee;

I am writing to bring to your attention the need to review and increase our EMS billing charges. As you may be aware, our current EMS charges were last updated in 2017. Since that time, we have conducted careful consideration of these charges during each budget cycle. However, the cost of operations has grown exponentially over the past several years, creating significant challenges as we find prices increasing for supplies and equipment.

To ensure that our charges remain appropriate and reflective of current economic conditions, we recently sought the expertise of our billing company to provide local data for comparison against our current EMS billing rates. Their analysis highlights a gap between our charges and those of similar services in the region, further underscoring the necessity of an adjustment.

Another challenge worth noting is the impact of our payor mix on our EMS operations. The demographics and financial makeup of our patient base directly influence our revenue. Our service model is user-based, so it is crucial that our billing rates adequately cover the cost of service delivery. Without an increase, we risk compromising our ability to maintain the high standard of care that our community expects and deserves.

Given these considerations, I urge the Committee to approve a resolution to increase our EMS billing charges. This adjustment is necessary not only to offset the rising costs of operations but also to ensure the long-term sustainability of our EMS services.

I appreciate your attention to this matter and look forward to discussing this further at our next meeting.
