As far as ordinance changes, we do not need any changes for the lane use arrows.

However, we do need a modified ordinance for the parking changes on the south side of Washington St. If they approve the additional 4 parking stalls, then we will need to modify the ordinance accordingly.

The would be Section 10.390 Parking Prohibited Washington Street (a). The proposed new ordinance would read as follows, "On the south side of Washington Street from the west curbline of South 8th Street for a distance of 40 feet".

Typically, we would need to change the ordinance for Angle Parking, but I do not see Washington St. in the current code for angle parking. So, if they approve the removal of angle parking on Washington St., then the current ordinance will be accurate.

If they do not approve the removal of the angle parking, then we would need to add the south side of Washington St. for angle parking to the ordinance.

Hope this is not too confusing.

Subject: Washington St. - S. 7th to S. 8th St. & Intersection of S. 8th and Washington St.

I received a call yesterday from Brandon Bartow (920-374-0323) regarding complaints he has about the area of S. 8th and Washington St.

He said that the significant amount of truck traffic going to and from Briess on Washington St. is a major issue. He said that with the angle parking on the south side of Washington St. the semi-trucks are forced to drive over the centerline and into the oncoming lane of traffic.

He would like to see the angle parking returned to parallel parking in the block between S. 7th and S. 8th St. This should probably be brought back to the Public Safety Committee.

Brandon also feels that the eastbound lane designation should consist of a left turn only lane and a thru and right turn lane.

I told him that we just were pondering this same question at a meeting on Monday.

After looking at this and taking the attached photos, I see that the Right Turn Only and Arrow was placed too far to the south. It is partially in the parking lane.

We could actually get another 3-4 parking stalls striped on the south side of Washington St. just west of S. 8th St.

I would think that we could change the lane designations and make it a left turn only lane. The skew angle for the through movement did not seem that bad especially if the angle parking is eliminated.

See the attached drawing with the proposed changes.

Who is making a final decision on the lane designations and the parking stalls???

What about the angle parking issue?? Can we ask for that to be placed on the March Public Safety Agenda???
