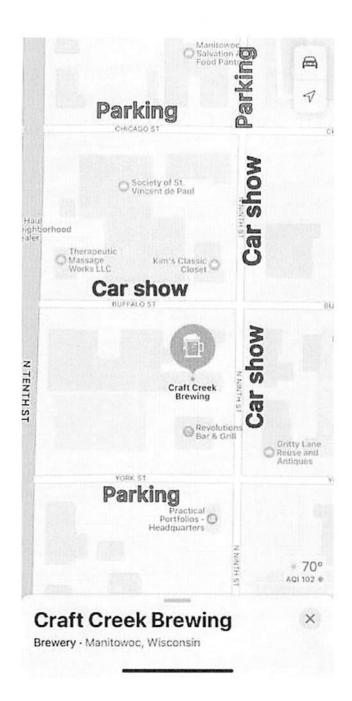
Why should this Waiver of Fees be granted?
