Good morning Brian,

Thanks so much for your time this morning. This email is to confirm our discussion that since the City is precluded by state law from reducing the Municipal Judge's benefits during a term, the split of 60/40 for premium contributions will continue for the remainder of his term, which expires in 2024. When benefits are set for the position in fall of 2023, the City will address your underwriting requirements and recommend the Common Council change the premium to a 50/50 split (or whatever Health Partners has as a minimum split) for the term that begins in May 2024.
